911 Blue Earth County 9-1-1.

RA Um, there's a guest here throwin' stuff and he's behind the desk in the um (inaudible). Can you send someone like ASAP? Like he's breaking stuff in the hotel.

911 And which hotel is this then?

RA The Country Inn and Suites.

911 Alright.

RA 1900 Premier Drive.

911 Okay. And you don't know who he is or?

RA No I don't know who he is. He's behind the desk. Now he's laying down. He threw something at my face. And he's breaking (inaudible) 1900 Premier Drive, Country Inn and Suites.

911 Okay. You're the clerk there right now? (inaudible)

RA Yes.

911 I'll get...are you able to get some place safe right now?

RA Um, I'm just in the hotel so I don't know.

911 Okay. (Background noise) talk to my officer real quick okay?

RA Yup.

(inaudible)

911 And you said you think he is a guest?

RA I don't know what he is.

911 Okay. You hurt at all?

RA And now he's leaving. And now he's kicking stuff.

911 Are you hurt at all?

RA No, close to being.

911 Does he have any weapons at all?

RA I don't know. I don't think so.

911 Is he white, black, Hispanic, Asian.

RA He's white, he's about 6-5-ish. Now he doesn't have on a shirt and he (inaudible) he's bald.

911 Okay and is he outside then? Or is he still...

RA Yeah, now he's coming back in.

911 (inaudible)

RA (inaudible) now.

911 If he gets outside again I want you to try to lock the door okay? But I don't want, I want you to stay away from him right now.

RA Now he's inside.

911 Okay just keep tryin' to stay away from him.

911 Copy. I do have an officer, I do have an officer just pulling up there right now? What is your name ma'am?
