HISTORY AND TRADITIONS

New Year's celebrations date back to ancient Babylon 4,000 years ago. The observances were usually held in March when there was an equal amount of sunlight and darkness. They considered this the beginning of a new year. They were also honoring the victory of the Babylonian sky god over the evil sea goddess Tiamat.

As civilization progressed, different sections of the world associated the new year with different reasons. Egypt, as an example, observed the new year with the yearly flooding of the Nile River. A great many of the new year's celebrations became associated with

Romulus, the founder of Rome, created a calendar of 10 months and 304 days. A later Roman ruler, Julius Caesar, added two additional months, Januarius and Februarius.

When he created the Julian Calendar, astronomers and mathematicians were consulted. The Julian calendar is much like our calendar of today.

January, named for the god Janus, was depicted with two faces, one looking forward and one looking to the past. February is named for the god Februus, meaning purification, a time

to prepare for the future.

Pope Gregory XIII established January 1, 1582 as the official first day of the new year.

Slowly, traditions began to be associated with New Year's Day. In Spain, swallowing 13 grapes while the clock is striking will bring good luck in the coming year.

A tradition associated with the southern United States is eating black- eyed peas for good luck and eating something green so you will receive money in the new year.

Cuba, Austria, Mexico, Portugal, and other countries always eat pork to make sure they have a prosperous year. Some countries always eat a round cake to indicate the year has come full circle.

Another tradition in English-speaking countries is singing "Auld Lang Syne" at midnight. Many people make resolutions, which probably date back to Babylonian times.

The dropping of the giant ball in New York's Times Square is seen by millions of people. The tradition began in 1907. The giant ball will be covered this year with thousands of Waterford crystals and 32,000 LED lights. Another New Year's tradition in America

that was especially popular midcentury was Guy Lombardo and his Royal Canadian Orchestra broadcasting live from New York



City the "Auld Lang Syne" song as the clock welcomed in another new year.

Dropping things to celebrate the New Year has become popular in cities. They drop all sorts of things, such as dill pickles in Pennsylvania and oppossums in Georgia.

The Jewish new year is known as Rosh Hashana, which translates as "Head of the Year." The date changes according to the Jewish calendar.

The Chinese welcome the new year in the

spring. The midnight kiss probably origninated in England and Germany. Some people celebrate the New Year with a "Polar Plunge" by swimming in freezing water.

It appears the new year gives people an opportunity to start a new beginning, but we express nostalgia at the close of the year.

Three Kings Day and the Twelve Days of Christmas

From gifts and camels to Epiphany and Mardi Gras, January 6 traditions explained

Three Kings Day is not usually observed here, but it is an important day in many countries, especially in Latin America with parades and

It is on this day in many Spanish-speaking countries when children receive presents on the "Dia de Las Reyes" (Three Kings Day).

The Three Kings bring presents to the children just as they did to the baby Jesus.

This is probably where the tradition of giving presents on Christmas day began.

Just as in the United States children leave milk and cookies for Santa, the children who observe Three Kings Day leave their shoes out and fill them with food for the camels. In appreciation, the Kings leave small gifts for the children for remembering the

A large part of the Christian world observes January 6 as Three Kings Day, also as the Epiphany. The meaning of the



word epiphany is when suddenly you find yourself understanding or become convinced of something. When the Magi, who were Gentiles, came to worship baby Jesus, they had

an epiphany.

According to tradition, there were 12 days from the birth of Jesus until the Wise Men came to visit baby Jesus.

We are all familiar with the

song, The Twelve Days of Christmas. This is the time between the birth and the visitation; this is how the song got its name.

William Shakespeare recognized the 12 days of Christmas; he wrote a play titled The Twelfth Night.

Epiphany, January 6th, the same day as Three Kings Days, marks the beginning of the Mardi Gras season which lasts until Fat Tuesday in February.

Many Protestant churches do not observe Epiphany and do not include it on their church calendars. Other Christian churches feel it is

very important as it was the first contact between the Jewish Messiah and the Gentile

Item of interest: It is thought that the tradition of Christmas caroling began with "wassailling" centuries

On the 12th night, the English had a long history of getting together and singing. The singers were rewarded with hot mulled cider known as wassail. This evolved into what we know as Christmas caroling.

Wassail is actually a greeting meaning "Be in good cheer."
