Dear Speaker Rozzi,

This correspondence serves as an official request to call the Pennsylvania House of Representatives into Regular Session to consider Senate Bill 1 (SB 1).

As you know, SB 1 includes the proposed constitutional amendment providing a two-year window for victims of childhood sexual abuse to file lawsuits in court, ones currently prohibited by a statute of limitations. Two additional proposed constitutional amendments are also included in SB 1 – one that provides for the disapproval of regulations and another that requires qualified electors of Pennsylvania to provide a valid form of identification at each election.

Providing relief to victims of childhood sexual abuse is an issue that has been discussed and debated in the Pennsylvania House of Representatives for at least the last 10 years. As Speaker of our chamber, the highest position, you are the one person who can now call us back into Regular Session so that we can finally address this issue.

We are only one step away from completing the legislative part of the constitutional amendment process. Getting these constitutional amendments, including the one you have been so passionate about, on the Primary Election ballot will give the people of Pennsylvania the opportunity to have their voices heard on these issues.

We again recognize that you are the one person in Pennsylvania who has the authority to call us back into Regular Session so that SB 1 can be voted upon. We respectfully request that you consider doing so immediately.


