COMPLAINT

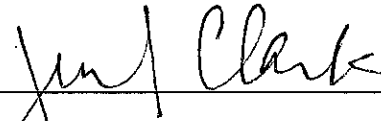
JENNIFER CLARK, Deputy County Attorney, deposes and says that on or about the 27th day of April, 2015, in Missoula County, the Defendant committed the offenses of
COUNT I: PROSTITUTION, a Felony, in violation of Montana law, namely: Mont. Code Ann. 45-5-601[4], punishable by not less than 25 years or more than 100 years MSP and a \$50,000 fine; COUNT II: PROSTITUTION, a Felony, in violation of Montana law, namely: Mont. Code Ann. 45-5-601[4], punishable by not less than 25 years or more than 100 years MSP and a \$50,000 fine.

The facts constituting the offense are:

COUNT I: On or about the 27th day of April, 2015, the above-named Defendant offered to engage in sexual intercourse for compensation with John Doe, age 16, for compensation. The defendant is over age 18.

Officer Smith was discussing the incident with Sgt. Hebert and used the phrase “age of consent.” Buscaglia overheard him and stated, “But I am 72 years old.” Officer Smith recovered just over \$400 from Buscaglia’s shirt pocket. Buscaglia admitted that he thought the boys were 14 and 15 years old and he defined “sex” as performing oral sex on both boys.

John Doe, age 16, stated he was at Taco Bell and observed the defendant flashing a wad of cash at him. He became uncomfortable and called a friend, Jim Doe, age 16, to pick him up. The male approached them and asked something along the lines of "\$100 a suck each?"
