Notice is hereby given that Jordan Linn Graham appeals to the United States Court of Appeals for the Ninth Circuit from the

(xxxxx) Judgment of conviction and sentence (change of plea held December 12, 2013 and sentencing held and Judgment entered March 27, 2014; appealing upward obstruction of justice adjustment; denial of acceptance of responsibility points; failure to resolve government's sentencing argument regarding premeditation; failure to dismiss Count I with prejudice; breach of the plea agreement and reasonableness of the sentence.
