I am writing to you on behalf of Jordan Graham. My name is Gary Jacobs, I am a retired USAF veteran with 20yrs of service and a member of Rocky Mountain Baptist Church in Kalispell, Mt.

I first met Jordan when she was 3 to 4 years old and her mother, Lindy (Grob) Rutledge, began attending ~ RMBC. Lindy was a single mother and very protective of her little girl. Jordan was a beautiful child, compliant, and very shy.

When she entered 1st. grade, she began to attend our junior church group service that my wife and I led twice a month. When she entered the 4th grade she joined our weekely Sunday school class and was a faithful member for 2½yrs. As with 311 the children and we taught, we came to love Jordan very much.

Approximately 2-3yrs after she joined our church, Steve Rutledge came into fellowship of our church and he and Lindy began to keep company and their relationship grew into a marriage. Within a year their son was born. Steve and Jordans relationship bloomed and he took her as his own, and she called him dad. Jordan and her brother have always been real close.



Nonetheless, her superlative attributes do not discontinue there by any means; she is irrefutably a magnanimous person. When any individual does something malicious to her, she does not use a manner of retribution, rather, a pardoning, empathetic, and longsuffering attitude toward their comportment thus showing no sign of holding any grudge of any kind. This is why I take great pride when I am allowed the opportunity to say that she is my sister.

Jordan has done so much for me to be proud of and has accomplished copious noteworthy accomplishments. Whenever I needed help with a project she was willing to step in and help wherever she was needed. She would go out of her way to help others when they


Sentencing Letter #9 Page 1 of 2 needed help. She was there for others if they needed someone to talk to or a shoulder to lean on.

Jordan is a sweet young lady that no one would ever think that she would ever be in the situation she is in. Jordan has never shown any characteristics that would be even close to be endangering to others. I have been her father since her mother Lindele and I were married April 20, 1996. Jordan has never met her biological father. Jordan was four years old when Lindele and I were married. We dedicated ourselves to bringing her and her brother Marriel up in a Christian home, and church that follows the word of God. We have attended Church services every Sunday and Wednesday since she was about four. Jordan would often volunteer in the nursery there and care for the 0-3 year old children. She would also volunteer to help her mother in the junior Sunday school class to help teach the word of God to the 3-10 year old children.

During Jordan's school years she was reserved, quiet and didn't fall into peer pressure. She did her own thing and did very well in High school. Jordan never smoked cigarettes, did drugs, drank or even said a foul word. If she didn't want to do something nobody could talk her into it. She was also very careful as to what she said. She would not want to offend anyone. She would not talk trash about somebody else behind their backs. She was not one to gossip. She was an A student all through her school years. She graduated with honors and probably could have qualified for college scholarships, but she decided to pay for her own college expenses. She attended Flathead Valley Community College working on a degree in accounting. She worked at a day care

and later she went on to be a nannie for a couple of families in Kalispell. The Kids loved her very much and she enjoyed what she did for a earning her way through college. She is very good with kids, and understands them. I thought she would make a great elementary school teacher, but she wanted to be an accountant.

Jordan didn't date until she was eighteen. We were fairly strict on the matter. She kind of dated one other young man before she and Cody began to date named Drew. She would not date anyone that had not made a profession of faith. If they were not saved she would just be friends with them. Drew never got saved, Drew lost interest and went on. Cody got saved a few months after he started going to church with Jordan. Soon Cody's mother Sherry came to the church as well. They both joined the church I believe at the same time. Jordan and Cody dated for about nine months until they were engaged. Cody took me to dinner one night and asked my permission to marry Jordan. I told him I'd approve for them to get married and would love to have him for my Son in law. Cody waited another three or so weeks before he actually popped the question. They spent the next six months preparing for the wedding. They wanted a traditional wedding and wanted to follow the traditional route. They never moved in together until the day they were married. They never spent a night together. I believe in my heart Jordan kept herself until she was married. It was just a promise I think she made to herself to be abstinent until the day she was married. The week during their marriage I saw no signs of unhappiness. As far as I could tell they were two very happily married people that had a wonderful love for each other. I was among the ten or so fellow church members that gathered at the local Dairy Queen in Kalispell after the evening Sunday church service before Cody's death. They sat at a table across and behind my wife and I. They sat with I believe Michael my son and someone else, which I can't recall. They left after eating and 2

Sentencing Letter #10 Page 2 of 4 went home. I saw nothing out of the ordinary. They said good night to everyone and left. The events that followed I still can't understand.

Jordan has always been a non-confrontational person. She would rather walk away and not want to argue. I'm sure that if someone were to forcefully bring her back after she walked away that she would resist and not want to talk until later. She did not like anyone talking loud or yelling. She would not yell back. Her only defense was to walk away. I've had her walk away when I had raised my voice to her.

I recall that one time she tried to plow our driveway with the four wheeler. She was trying to do a good thing, but broke the winch that lifts the blade on the four wheeler. I got angry and yelled at her, but she didn't feel she had done anything bad and walked away while I was still explaining in a louder than usual voice that if she didn't know how to run the plow not to try and plow snow. I later realized that she had only let the 50 ft. line out all the way and had spun it back on the spool backward. I felt really bad and apologized for accusing her of breaking the winch. She never drove the four wheeler again.

Jordan was a great role model for several younger girls. She was like a big sister to them. She volunteered her time in mentoring and guiding them in right living as a young Christian. She would take them shopping, take them to the park or just hang out and be their friend. One young lady was being a little rebellious toward her parents and Jordan was able to get that relationship between the parents and her back in order by encouraging her to follow the Bible and read what God's word states about the parent child relationship. Honor thy Father and Mother is one verse that sticks out in my mind. Today that same young lady has a different mindset and a better relationship with her parents and studies her bible. I have heard that next year she plans to attend a Bible college after she graduates high school. Jordan wanted to settle down and just be a mother and a housewife after she and Cody were married. She guit school and wanted to devote her life to a new life as the wife of Cody Johnson. There is no way I would believe that the events that happened could be deliberate. I feel in my heart that Cody's death was an accident and maybe a case of self- defense that had horrible devastating consequences. People react in different ways when they fear for their own life. Why she decided to tell stories about the true events are unknown and unfortunate, but not a reason for long prison term.

I ask you to grant Jordan some leniency, and a chance at living her life as a Young Christian woman. She did break the law, but I feel in my heart she did not intentional harm anyone. I think she was so scared that she didn't know what to do. I can youch for Jordan as a person that cares deeply for others. She has never shown any tendencies toward being a danger to anyone else or herself. I believe there is a life that she can still follow that can be a positive role model and even better person altogether through what she has already experienced. I love my daughter very much and still have a great belief in her love for others. I do pray and ask that you diligently consider all the facts and evidence of this case and rule accordingly. I trust that you will make the proper decisions concerning Jordan with her and others in mind. Thank you very much for you time.
