- 1. Health Care Access and Refugees with Special Needs:** Given that IRC has not yet established strong relationships with providers of specialized mental health services and resources for severely disabled, clients with these needs will not be placed in Missoula in the initial phase. Missoula is a regional medical hub with specialty coverage available to support the majority of refugee medical conditions. Missoula has two primary health care facilities: St. Patrick's Hospital and Health Sciences Center and Community Medical Center. St. Patrick's is affiliated with the Providence Health & Services and is the largest medical facility in Western Montana. It has 253 licensed beds and is a Level II Trauma Center, the only one in the region. Community Medical Center is in southern Missoula and is the only hospital in Western Montana with a dedicated Pediatric Intensive Care Unit. In addition to the two specialty medical centers, the Missoula City-County Health Department operates the Partnership Health Center, which is a large, low income community clinic accepting Medicaid and other forms of insurance. There is also the Western Montana Clinic, a large group practice with over eighteen different specialties and four locations around Missoula.
- 2. Community Engagement:** Thus far in FY16, IRC has conducted three week-long site visits to meet with local residents, local elected officials and government agencies. IRC continues to

work with Soft Landing Missoula to hold outreach meetings and identify additional groups and agencies to contact. One positive result of these meetings was advice from Missoula's mayor and the head of United Way on suggested office sites. During the a visit in April 2016, the Senior Advisor and Senior Director for Resettlement met with the Montana state coordinator, state health agency, and a member of the governor's staff in Helena, which was the first face-to-face meeting between the IRC and state officials. The meeting centered on the quarterly consultation process and plans for the opening of the IRC office in Missoula. As a result of the meeting, the IRC became better acquainted with the state government and developed a more comprehensive understanding of the political climate in Montana.

During FY17, IRC local staff will continue to meet with local agencies and public officials to develop better working relationships and institute a quarterly consultation process. IRC, in partnership with Soft Landing Missoula, will hold four public meetings which will increase community awareness of the resettlement process and develop volunteers or potential donors. IRC will record the attendees and track the new volunteers and donors to assess the impact of the meetings.
