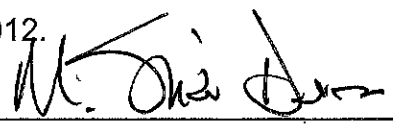

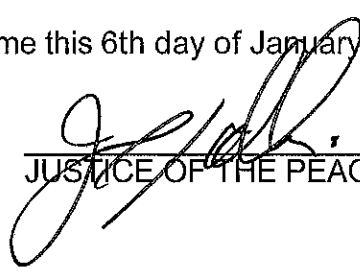
The facts constituting the offense are:

M. SHAUN DONOVAN, Deputy County Attorney of Missoula County ,
Montana, being first duly sworn upon oath, deposes and says:

I have read official law enforcement reports regarding the investigation of
BEAU DONALDSON for allegedly committing the offense set forth in the
accompanying complaint and based upon the information contained in the reports,
if true, believe probable cause exists to justify charging the above-named defendant
as specified in the complaint.

In December of 2011 Missoula Police Detective Guy Baker interviewed an
adult female, pseudonym "Jane Doe" (JD), who stated that on September 25, 2010,
BeaU Donaldson, had sexual intercourse with her while she was sleeping at his

residence after consuming alcohol at a house party. Donaldson was a person she had been friends with for years but never involved with romantically.

According to JD, she went to sleep on a couch fully clothed, and woke up a few hours later to find her pants and underwear pulled down and Beau Donaldson having intercourse with her. After Donaldson concluded the act, he pulled up her clothing, covered her up and left the room. JD immediately left the residence and called her mother who reports JD was hysterical and crying, "he raped me" identifying Donaldson as her assailant. JD called a female friend who had also spent the night of the party at Donaldson's house and warned her to leave immediately because Beau had raped her. JD was taken immediately to the First Step Resource Center and submitted to a sexual assault examination.

According to JD, her mother and other witnesses, Donaldson came to JD's home the following day where JD confronted him about having sexual intercourse with her without her consent. After initially denying the act, he become emotional, admitted the accusation and apologized.

On December 23, 2011, in a telephone conversation with JD monitored by Missoula Police Detectives, Donaldson admitted he took sexual advantage of JD and had sexual intercourse with her while she was sleeping. He apologized repeatedly and attributed the act to a "drinking problem" as well as pain medication.
