Good Afternoon Folks,

Here is the transcript from	hearing. Judge Larson clearly	took supervision away from
Youth Court because I allowed	to make a decision on his own as	to whether or not he wanted
to participate in the Drug Treatment I	Program. Due to the fact that	said no, Judge Larson has
stated that I am not truthful, non-con	npliant with the Court Order, and s	subsequently my office is no
longer competent to supervise	. This feels hostile and retaliatory	towards me directly for giving
a voice as to whether he wants	to participate in what is suppose t	to be a voluntary program.

I also have grave concerns that Judge Larson is asking for information that my Juvenile Probation Officer is doing as a normal activity of his daily probation officer's work. The JPO is well aware of school attendance, grades, therapy activity at Talbot, family interaction, and progress in the program. The JPO meets with weekly. There has been evaluations completed per the Disposition order, as required but since it is post-disposition none of these evaluations are required to be submitted to the Court. They are used for case management purposes, as they are in every case.

In my 20 years of probation service, I have never provided the information that Judge Larson is asking for to any other Judge post-disposition. Those are normal tasks of a probation officer nor have I ever had jurisdiction take away from Youth Court by a District Court Judge. It truly feels vindictive and hostile towards me personally for standing up for the kids who state that they do not want to participate in Drug Court. I unfortunately will continue to stand up for these kids, despite the negative consequences that continue to come my way. These youth need a voice and someone they can trust. I will continue to be that person. I have not forced them to sign anything, despite what I am being accused of and I will continue to stand up for each and everyone of these kids because they deserve it. I take pride in my honesty, integrity, and willingness to stand up for what I believe in. The kids of Missoula and this office is truly valuable to me and take pride in showing up everyday to make it the best that I can with an amazing team of people behind me.
