### **VOTER REGISTRATION:**

**Tuesday, April 14, 2026:** Last day to register to vote or update your voter registration information for this election.

Mailed voter registration applications must be received in this office postmarked on or before the deadline.

Same Day Registration is now available, however, Same Day Registrants must vote a provisional ballot which will be considered and cast after the election, if accepted.

**You may request an application to vote by mail online via the VA Department of Elections website at [elections.virginia.gov](http://elections.virginia.gov) OR**

**by contacting this office to request that an application be mailed to you.**

**Friday, April 10, 2026:** Last day to request a ballot by mail. Applications must be received in this office no later than 5 PM.

**Friday, April 24, 2026:** Only mailed ballots postmarked on or before Election Day and received no later than 12 Noon (Virginia time) on this day will be counted.
