I asked Andrew the name of the barber who gave him the information that was possibly being molested and he refused to provide me to	hat

As I was waiting for Edward I notice multiple vehicles in the parking lot and it appeared the church was towards the end of the ceremony.	
I then made contact with Edward Loza and I explained to him the reason for the check welfare. Edward briefly stated he knew had

On July 25, 2019 I responded to the Peter Piper at 5969 S. Calle Santa Cruz. In reference to a anonymous female who wanted to talk to police about an incident that was occurring at her church. The incident the female was discussing was documented the previous night under the listed case #1907240625.

Upon arrival I spoke with the female in her 40-50's who advised she was a member of the Golden Dawn Tabernacle located at 301 East Los Reales. She advised she had been a member of the church for 30 years. She advised the pastor was Isaac Noriega. She advised she went to the church with her entire family. She stated there was a male member at the church named Benjamin Paul Simarano who was approximately 27 years old. She advised she heard from other members of the church that was having a sexual relationship with Benjamin. She also heard that the pastor Isaac was aware of the situation and did not do anything to intervene. She advised there was a church member by the name of a Manuel Martinez who had stopped going to the church and had evidence that she believed he had turned over to the Pima County Sheriffs Office. She said the evidence consisted of some sort of recording proving that was having a sexual relationship with Benjamin. She advised there was a named who was also involved with Benjamin sexually. She advised she had heard third-party information that was given a cellphone by Benjamin so that she could take and send them to him. The female appeared very nervous and reluctant to provide information. She advised if the church found out she was communing with law-enforcement she would be excommunicated from the church which her entire family attends.

She advised she did not want the incident to be "swept under the rug" but did not know what else she could do.

A review of the listed case revealed Officer Donato was able to speak with on the previous night there was no evidence to support their allegations.

I advised Sgt Esquivel of my findings. He advised me to forward the case to Sgt Lopez.

This concluded my involvement with the investigation. See case for further details.

July 24, 2019 I responded to 301 E. Los Reales in reference to a sex offense call in which a caller reported that his vas sexually active with a 27 year old male. When I arrived, I contacted Andrew Loza who was waiting outside of this address. Andrew stated that he heard from, a reference that he wished to keep anonymous that was being molested. He indicated that is a member of the Golden Dawn Tabernacle Church and he was a former member. Andrew told me it was a "Doomsday Cult" and they groom all of the females and juveniles in the religion for sexual activity. Andrew stated that the church grooms the young women and marries them off to adult men. Andrew advised that he experienced molestation like incidents by members of the church to include the pastor when he was juvenile and wanted to help his family members if he could. Andrew stated that he had never met and indicated that the church keeps everyone very separated from society. Andrew stated members of this church have been covering up child molesting incidents for years and said it normally does not get reported because the victims are taught not speak against the church and that they were told how to talk to Police. He stated the molesting incidents normally occur during their praying time that consists of dimming the lights down and inappropriately touching juveniles. At this time, Micaiah Loza arrived. Micaiah advised that he had left the church and recently gotten in contact with Andrew Loza, He advised that Andrew had told him about the incident involving and spoke of how the church had kept him from seeing Loza. He stated that the church does not physically force, restrain, or imprison any of the members. I asked how they punish people who break their rules, Micaiah stated that the church, plays mind games, "put you on blast" and make violators sit in a room and be prayed for. Micaiah provided a website, which posted. Micaiah advised that not only were there very strict rules, but several members of the church could not leave the church, could not go to school, and they were not allowed internet access. Micaiah described an incident in which a child passed away after choking on something, but the church did not allow Paramedics or Police be notified. Micaiah stated that the only help permitted by church staff, was prayer.

She and her husband, Chris were raised in the Golden Dawn Tabernacle Church and they continued to attend as adults.  attended the school. was expelled from the school after he confronted Ben with allegations of sex abuse to minors. She told me how she knew certain people involved in this case. Joann said Ben Samorano is only a member of the church; he's never been in leadership. He works at TAZ Plumbing. Andrew Loza, one of the reportees, does not have first-hand knowledge of any of the allegations in the report. He heard about the situation involving so he wanted to help. She's known Andrew for a long time because he too used to be a member of the church. He left a long time ago. Emmanuel Martinez is
I told Joann what talked about in their interviews. She said told her just today that things happened that she had not already talked about. One thing was the Joann thought that may have occurred anytime between November 2018 to January 2019 visited their home regularly then). Joann did not have personal knowledge of anything inappropriate happening on the church premises. She became aware that Ben gave a phone "last year" (maybe Summer 2018). She caught him with it and confronted him about where it came from. She did not remember if it was an Ipod or an actual phone. When she found out about the phone, are an away and was picked up by Ben. She mentioned smart phones are taboo for members of this church. Adults are allowed to have flip phones, but kids are not supposed to have any.
She described Ben as "super manipulative". She said he portrays himself as normal to most people, on the surface. Joann alleged that he can "hack" into peoples' phones/email/social media accounts. Joann's husband cheated on her in 2015. Ben found out about it and spread the information to other church members. He did the same with the woman involved with the affair (and her husband).
Joann is estranged from her husband. She found out he had a series of affairs with different women, starting in 2015. After marital problems began. Ben befriended and she was okay with that. During this time, sometimes used her phone to communicate with Ben. She, too, communicated with Ben from time to time, but only in a platonic manner. Ben sent her messages praising her beauty and kindness. He also bad mouthed her husband. She, too, bad mouthed her husband, to Ben. In August 2018, her husband confessed additional adultery to her. She was upset and sought consolation in Ben. Ben invited her to his home, so she went, bringing him cookies. After she arrived, they hugged. "It just
happened" she said. She admitted that she gave him and allowed him to record some of the incident. He told her later that he deleted the video, assuring her he shared it with no one. She found out later (after she left the church) that had seen the video. About a week after the incident, he asked Joann for a topless photo; she refused. He then sent her a topless photo of another female from their church, telling Joann that he backed into her phone and to get it. In Fall 2018, she relented and decided to share topless photos of herself with Ben. He
started asking her to do certain things for him (when he saw her at church) such as wear certain color clothes and not wear underwear. Ben did not mistreat her or "blackmail" her. Ben complained to her about his sex life with his wife. Joann went on to say that she and Ben engaged in a full-fledged, completely consensual, sexual affair that lasted until February 2019. She has told no one else about this. She is concerned that he
may have recorded other sexual activity between them, and if so, it was without her permission. The only act anyone else knows about (she admitted it to others) is the aforementioned when dropping off cookies to Ben's house. Joann said she had sex with Ben in multiple

Joann left the church and her home (separated from her husband) in April 2019. When she told church hierarchy about her affair with Ben, the

church leaders questioned Ben. Her husband also questioned him. Ben denied everything to everyone. Talking about the church, she said "Your reputation is run by what the church knows about you". She said she told the pastor (Isaac Noriega) about the abuse by her husband, yet he ignored her, and other couples going through similar things. Joann says that husbands, in that church, can do whatever they want to do with their wives and children and the pastor still supports them. Joann talked about the church premises, specifically the school. She said school is held in a hidden area in a building on the southwest side of the property (the old sanctuary). There are no safety measures, like fire alarms. Young girls are the teachers; they are not certified. She was told that the program is considered homeschool through the "A/BEKA" program, and that is how the program is allowed to have non-certified teachers. Classes are K-12, but students get their GED outside of the church. Most students get a job with a church member's company after "graduating". The school does not allow technology/internet. Before ending our conversation, Joann mentioned that she was worried about a situation in her sister's home (Stephanie Gutierrez), involving possible child abuse by her brother-in-law. I suggested she call police and/or DCS to make a report with the specific information she had. On 082819, I spoke to Joann Baquera again, as she indicated that she had more details about the case. She said the email that was something set up for him by Ben, around the time that he ran away (and Ben picked him up that night). She provided the email address: said he last used that email in about January 2019. He did not know the password to access it. what email account he used to communicate with (allegedly stands for "proud sexy Joann also told me more about her sister's family situation. She said it was possible that her brother-in-law, Jacob Gutierrez, had somehow recently harmed his 2 yr old daughter (in a minor way). I made a report about this to the DCS Hotline (Matt Carpenter #2765). I was advised that the report was being handled by Supervisor Lily Kunkel.

On 082819, I requested that gmail account be preserved by Google in anticipation of obtaining a search warrant for the contents.

On 090619 Joann Baquera called me. She said her cousin, Graciela Chacon, told her about receiving strange messages from unknown phone numbers regarding personal photos of her that had possibly been "hacked" from her phone. She said the cousin thought the numbers may be associated with "burner phones" used by Ben Samorano. Joann forwarded me the messages and I later had them scanned into the case file. The numbers used to contact Chacon were 1-732-708-2707 and 1-601-429-2906. I checked a local police database and found no contacts with either of those numbers. One of the screenshots was of a Whatsapp notification. Joann also said that she located an email address that Ben gave to her son so they could communicate. She assumed that Ben had more than one email address, but this was the only one located in sold phone. It appeared to be a contact for a Cricket phone number (number not listed). There was a photo of a great white shark with its mouth open and the word "Emperor" listed with it. Joann went on to say that as was messing with the old phone. he suddenly remembered the password for the email address Ben set up for him He told her the password was He looked in the account and all of the messages between him and Ben were gone, possibly deleted by

On or about 090619, I received notice from Google that the preservation request did not go through (my initial request did not have signature). said he had checked the account and there was nothing in it, I did not resubmit another preservation request.

On 092419, Andrew Loza left me a message regarding a case update. He also indicated that he was going to attempt to fight the protection order

taken out on him by the church. I spoke to him on 092519. I told him the case was still under investigation. He said he has heard that Edward) is allowing Ben Samorano to spend time at their house at night. He did not say that he has first-hand knowledge of this occurring.
On 092619, I obtained a copy of the CD with the recorded phone conversation from evidence. I listened to the contents and compared it to the summary provided to me by Andrew Loza. I found that the summary accurately reflected information on the CD. The conversation was between a female and a male. The female was referred to as by the male and she referred to him as "E-man" or something similar to that. In the beginning of the conversation, the female denied any sexual involvement with a male referred to as Ben or Benji. The male suggests, at various times, different things may have been involved with, sexually, with Ben She mentioned that Ben sent her videos via email. She admitted that he showed her a video of Joann Baquera on Ben. She denies that she performed on Ben, but later in the conversation, the male tells her he knows she performed on Ben and she does not deny that. In the middle of the conversation asked if the male was recording their call. He told her no and changed the subject. By the end of the conversation, primary concern was that the male was going to tell what he knew about her activities. The male indicated that he would not tell about the things she did with Ben.
On 072420, I went to I contacted After introducing myself, I explained why I was there. She indicated she was aware that an investigation had been started some time ago, but thought it was over. She knew the allegations involved sexual conduct
between her and Ben, but she said nothing like that ever happened. Her description of the situation as a whole was it was a lot of "drama".  She said she knew that of hers, Emmanuel Martinez and Andrew Loza, reported that there had been something going on between her and Ben, but it was not true. Said that the church she attends (Golden Dawn Tabernacle) is "cultish" and has strict rules (just like a website about the church outlines). She admitted that in the past, she and Ben spoke as (in person and by phone) but it went no further than that.
She was told of an affair between Ben and another adult woman (presumably Joann Baquera) by that woman who had found out about the affair. Said she is not aware of Ben ever having donee something inappropriate with an underage female.
