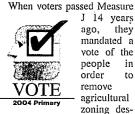
Q, R and S: Three measures on Tuesday's ballots ask voters to re-think zoning designations

Since 1990, there have been periodic attempts to change zoning in agricultural areas so some form of commercial endeavor can move ahead. Half of them have been successful in winning voter approvals.

Three more will appear on Tuesday's Napa County ballot as measures Q, R and S.

Measure R would allow the Pope Valley Market to expand, and reopen a restaurant, retain the post office and pump gas. Owner Bryant Morris has conceptual drawings of a small shopping plaza he envisions for

tings Wharf Road in Carneros. All three are seen by foes as encroachments into the agricultural areas of Napa County and are strongly opposed by the Farm Bureau and open space advocates.

Only Measure Q has garnered much publicity as election day approaches. Owner of The Nest, Kathy Smith, who is listed on financial disclosure documents as the director of operations for Alliance Bancorp, has funneled funds into her campaign coffers to help pay for mailings and

The Napa County Elections Office reported she made a personal contribution to the passage of Measure Q in the amount of \$11,000.

Attorney Tom Carey, of Dickenson, Peatman and Fogarty, represents the proponents of all three measures. He indicated there is little in the way of organized support for the plans.

Measure Q

Measure Q, the only one to attract significant funding, is also backed by the former deli operator on the site, Louis Pometta.

Measure R will decide the fate of this historic market and post office, located near the intersection of Pope Valley and Howell Mountain Roads.

The slow growth group, Get a Grip on Growth, has contributed slightly more than \$2,000 to help defeat Q, R and S.

The property in question had commercial zoning designation until the formation of the Agricultural Preserve in 1968.

The deli then became a nonconforming use.

The owners say, "Because we support the protection of agricultural lands, no other properties are eligible for this zoning unless they have operated commercially since 1968 and win a · subsequent vote of the people." The measure would allow up

to 15 percent expansion of the current building footprint, but opponents point out that it also would let them subdivide the property and build up to three stories, calling it "tourist-serving sprawl."

Owners say they have no plans to subdivide, but are simply seeking to do what the business has done for 45 years, but in a more comfortable setting.

Measure R

Measure R presents similar opportunities and arguments, although it was called into question early on because of the way owner Bryant Morris worded the petition to place it on the ballot.

Instead of rezoning the Pope Valley Store across Pope Valley Road - which some residents of the area consider to be more historic — the measure would rezone the Pope Valley Market. Opponents say the petition used to get the measure on the ballot was misleading.

Morris says he wants to do what other businesses in Napa County are allowed to do. That is, to apply for a use permit, allowing him to abide by land use ordinances to expand the facility.

Opponents say passage of Measure R would create more growth and development in that rural area. They also point out

Measure J projects on the ballot since 1993

- In November, 1993, Thomas West sought approval for a boat storage expansion at Lake Berryessa, although he hoped to alter more than 30 acres. Voters turned it down, with a 49,4 percent affirmative vote.
- In November, 1994, Bistro Don Giovanni sought to add outdoor seating at the restaurant on Highway 29 north of Napa. Sixty-five percent of voters gave it their
- In March, 1996, a Texas firm proposed a massive housing and commercial development at Soscol Ridge south of Napa. It was overwhelmingly turned down Measures W and X garnered only 16 and 14 percent yes votes, respectively
- . November, 1996, the Pumpkin Patch produce stand wanted to go beyond the
- agricultural use allowing only goods grown on the properly to be sold there. Fiftyfive percent of voters said yes.
- . In November, 1998, Brix Restaurant, formerly the Grape Vine Inn north of Yountville, sought to add seating and expand its septic system. Voters agreed with the proponents with a 52 percent affirmative vote.
- In January, 2000, following a hotly contested political debate, plans to renovate the old Aetna Springs Resort and create a resort there were defeated. Only 38.5 percent of voters fell that was a worthy plan.
- In March, 2002, Tom Aswad and John Campagna won approval for the expan-

Molly Banz and her angels descended on Molly's Angels Cafe Saturday evening to say good-bye to the restaurant through music and food.

Dozens of Napans crammed into Banz's restaurant making her cash register do something it hadn't done in a long time: sing.

"We've never had nights like this," Banz said, adding that if the restaurant had had more nights like Saturday, the eatery wouldn't have had to close.

Banz said that one of the reasons she had to close the restaurant was because it wasn't making money. Another reason was that she often found herself working 15-hour shifts, which didn't leave a lot of time to help people in need through her charnon-profit itable agency, Molly's Angels.

Patrons were treated to the acoustic sounds of Amber Estrada, a local musician, and Banz's English-style cuisine, including her tasty fish n' chips.

Among the people who came for the event were Molly's volunteers, friends and people she has helped.

Molly's Angels have new digs.

After hanging up her apron with the closure of Molly's Angels Cafe on Saturday, Molly Banz and her angels have taken up residence in a sprawling office complex on the corner of Highway 29 and Sierra Avenue.

Molly's Angels, a grassroots organization started in May 1999, is a nonprofit with an eight-member board of directors and about 5,000 volunteers dedicated to helping residents of the Napa community in times of trouble. With Banz at the helm. Molly's Angels fill the needs of those who may not qualify for help from such agencies as the Red Cross, Salvation Army and Catholic Charities.

The two-vear restaurant venture at Jefferson Street and Pueblo Avenue, where all the proceeds were routed back into the operation of Molly's Angels,
