Effective July 1, 2019, Saint John XXIII Quasi-Parish will be located at the site of the current Risen Lord Church (Marshall-Shadeland). The parish will continue to be served by the Institute of Christ the King Sovereign Priest and serve the faithful who desire the celebration of the liturgy in the extraordinary form.
