A RESOLUTION AUTHORIZING THE HIRING OF A SPECIAL APPRAISER

WHEREAS, Property Owner is the owner of certain property that is known and designated Block 25, Lot 20 on the Tax Map of the Town of Clinton, Hunterdon County, State of New Jersey, and more commonly known as 19 W. Main Street (the "Property"); and

WHEREAS, the New Jersey Economic Development Authority ("EDA") awarded the Town a grant to purchase the Property; and

WHEREAS, as a condition of the grant funding, the Town must obtain an appraisal report on the Property by an EDA-approved appraiser in order to determine the purchase price of the Property; and

WHEREAS, as a condition of the grant funding, such appraiser must be on a list of EDA-approved appraisers; and

WHEREAS, the Parties have each presented an appraisal report to the EDA in order to negotiate a purchase of the Property; however, the Parties have been unable to agree on a sales price for the Property; and

WHEREAS, the Town's appraiser was approved by EDA, but the Property Owner's was not; and

WHEREAS, the Property Owner has requested that the Town seek a third appraisal from an EDA-approved appraiser in an attempt to further negotiate the purchase price of the Property; and

WHEREAS, the Property Owner has agreed to establish an escrow to pay for work required to be performed by an appraiser employed by the Town in connection with the Property Owner's request; and

WHEREAS, the Town has selected Russell Sterling from the list of approved appraisers; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 *et seq.*) authorizes the hiring of a professional without competitive bidding providing that the resolution authorizing the award of contracts for "Professional Services" without competitive bidding and the contract itself be made available for public inspection; and

WHEREAS, nothing herein shall obligate the Town to agree to a specific purchase price of the Property or to purchase the Property.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Town of Clinton, Hunterdon County, New Jersey, as follows:

1. Russel Sterling is hired as a special appraiser to provide an appraisal of the Property consistent with guidelines for EDA grant funding.

2. The Mayor and Clerk are hereby authorized and directed to execute an agreement with Mr. Sterling

consistent with this Resolution and in a form approved by the Town Attorney.

3. The amount of such contract shall not exceed \$5,000.00.

4. This contract is awarded without competitive bidding as a "Professional Service" under the

provisions of the Local Public contracts Law, subject to N.J.S.A. 40A:5-11, which states that "No

local unit shall be required to advertise for bids for any of the work performed pursuant to 40A:5-

4.

5. A notice of this action shall be printed once in an official newspaper of the Town.

6. This Resolution shall take effect immediately and in accordance with applicable laws.

RESOLUTION CONDITIONALLY AWARDING CONTRACT TO SIV AMBULANCES, LLC FOR THE PURCHASE OF TWO (2) AMBULANCE REMOUNTS THROUGH THE SAVVIK BUYING GROUP, LLC COOPERATIVE PURCHASING PROGRAM

WHEREAS, the Town of Clinton's emergency services provider, South Branch Emergency Services, Inc. ("South Branch"), recommends that the Town of Clinton (the "Town") obtain services and materials to remount two (2) ambulances for South Branch to continue providing emergency medical services to the residents of the Town; and

WHEREAS, South Branch has researched vendors that would achieve the Town's goals and determined that the desired services and equipment may be procured through a nationally recognized and accepted cooperative purchasing contract between the Savvik Buying Group, LLC ("Savvik") and SIV Ambulances, LLC ("SIV"); and

WHEREAS, pursuant to N.J.S.A. 52:34-6.2b.(3) (as amended by P.L. 2011,c. 139) and LFN 2012-10, a New Jersey municipality may purchase goods and services without public bidding under the Local Public Contracts Law through the use of -recognized and accepted cooperative purchasing contract that has been developed utilizing a competitive bidding or contracting process by another contracting unit within New Jersey or another state; and

WHEREAS, also pursuant to N.J.S.A. 52:34-6.2b.(3) (as amended by P.L. 2011,c. 139) and LFN 2012-10, prior to making purchases under nationally-recognized and accepted cooperative purchasing contracts, the municipality must determine that the use of the cooperative purchasing contract shall result in cost savings after all factors, including charges for service, material, and delivery, have been considered; and

WHEREAS, South Branch has determined that the Town's use of the Savvik cooperative purchasing contract to procure the desired ambulance remounting services and materials will result in cost savings to the Town; and

WHEREAS, consistent with the Savvik cooperative purchasing Contract and needs of the Town, SIV has submitted a proposal to provide two (2) remounts of ambulances for the sum of \$367,688.50; and

WHEREAS, according to the Town's Chief Financial Officer, there are sufficient funds available for this purchase for this purchase in Capital Ordinance # 25-10.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Clinton, in the County of Hunterdon, State of New Jersey, as follows:

- 1. A contract for the purchase of services and materials to remount two (2) ambulances for the sum of \$367,688.50 is hereby awarded to SIV Ambulances, LLC without public bidding as permitted by law conditioned upon:
 - a. SIV providing certain required documentation, including proof of New Jersey Business Registration, proof of affirmative action compliance, a W-9, and any other documentation required under applicable purchasing rules and regulations.

- b. Review and approval of a form of contract by the Town Attorney.
- c. Certification of availability of funds from the Town Chief Financial Officer.
- 2. The Mayor and Clerk are hereby authorized and directed to execute all documents necessary to effectuate the purposes of this Resolution once all of the above conditions are met.
- 3. The form and terms of any documents to be signed by the Mayor and Clerk shall be consistent with this Resolution and are subject to approval of the Town Attorney and Chief Financial Officer.
 - 4. This Resolution shall take effect after any required notices are duly published.
