**RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF  
CLINTON AUTHORIZING THE SALE OF ANNANDALE HOSE COMPANY'S  
2005 SEAGRAVE MARAUDER ENGINE #46-1 FIRE TRUCK TO EWING  
TOWNSHIP**

**WHEREAS**, the Township of Clinton is the owner of a 2005 Seagrave Marauder pumper fire truck (Engine #46-1); and

**WHEREAS**, the Township recently acquired a new pumper truck to replace the 20-year-old Seagrave Marauder pumper truck; and

**WHEREAS**, as a result, the Township no longer has a need for the 2005 Seagrave Marauder fire truck; and

**WHEREAS**, the Township of Ewing is interested in purchasing the truck for \$35,000.00; and

**WHEREAS**, N.J.S.A. 40A:11-36(2) authorizes municipalities to sell personal property not needed for a public use to another municipality without the need to advertise for bids; and

**WHEREAS**, the Township wishes to sell the 2005 Seagrave Marauder fire truck to Ewing Township for \$35,000; and

**WHEREAS**, the fire truck is to be sold in an "as is" condition, without express or implied warranties;

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Township of Clinton, County of Hunterdon, State of New Jersey, as follows:

1. Clinton Township is hereby authorized to sell the Annandale Hose Company's 2005 Seagrave Marauder pumper fire truck (Engine #46-1) to the Township of Ewing for the sum of \$35,000.
2. The fire truck shall be sold in an "as-is" condition without express or implied warranties.

3. The Mayor and Acting Clerk are hereby authorized to execute any and all agreements or other documents and to undertake any and all acts necessary to effectuate the terms of this resolution, provided that any agreements or other documents shall have first been reviewed and approved by the Township Attorney.
