**RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF CLINTON  
AWARDING A CONTRACT TO RIVERVIEW PAVING FOR THE GLEN EAGLES DRIVE,  
MUIRFIELD LANE, AND HEATHER HILL WAY ROAD IMPROVEMENTS IN THE  
AMOUNT OF \$387,799.58**

**WHEREAS**, on September 4, 2025, bids were received and opened for the Glen Eagles Drive, Muirfield Lane, And Heather Hill Way Road Improvements in the Township of Clinton; and

**WHEREAS**, three (3) bids were timely submitted; and

**WHEREAS**, Riverview Paving, located at 859 Willow Grove Street, Hackettstown, New Jersey 07840, submitted a bid in the amount of \$387,799.58; and

**WHEREAS**, Riverview Paving's bid was the lowest bid received by the Township; and

**WHEREAS**, the Township Engineer and Township Qualified Purchasing Agent ("QPA") reviewed the bids and determined that Riverview Paving's bid conforms in all respects to the requirements set forth in the Township's bid specifications and to all applicable legal requirements; and

**WHEREAS**, the Township Engineer and Township QPA have therefore recommended that the Mayor and Council accept said bid and award the contract for the Glen Eagles Drive, Muirfield Lane, And Heather Hill Way Road Improvements to Riverview Paving as the lowest responsive and responsible bidder, in accordance with the requirements of the Local Public Contracts Law, N.J.S.A. 40A:11-1 *et seq.*;

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Township of Clinton, County of Hunterdon, State of New Jersey as follows:

1. The Glen Eagles Drive, Muirfield Lane, And Heather Hill Way Road Improvements contract is hereby awarded to Riverview Paving located at 859 Willow Grove Street, Hackettstown, New Jersey 07840, as the lowest responsive and responsible bidder.
2. The total amount of the contract is \$387,799.58, subject to such changes as the Maor and Council might approve in accordance with all requirements of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 *et seq.* and

implementing regulations.

3. The Chief Financial Officer has certified that there are sufficient funds available to finance the costs of the contract.
4. This resolution shall take effect immediately.
