WHEREAS, on November 13, 2024, the Township Mayor and Council adopted Resolutions 2024-235 and 2024-236, which authorized the acquisition of emergency responder gear and equipment from Continental Fire & Safety through NJ State Contract ## 17-Fleet-00805 and 17-fleet-00757 in an amount not to exceed \$25,000.00, and the purchase of emergency responder gear and equipment from All Hands Fire Equipment through NJ State Contract #21-FOOD-05224 in an amount not to exceed \$11,000.00; and

WHEREAS, the purpose of the authorized acquisitions was to furnish gear and equipment to SBES for its use in providing emergency medical and rescue services to the Township's residents;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Clinton, County of Hunterdon, State of New Jersey, as follows:

1. The donation to South Branch Emergency Services of the items listed on the invoices attached hereto as Schedule A is hereby approved and authorized.
