RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF CLINTON AUTHORIZING THE SALE OF SURPLUS PERSONAL PROPERTY NO LONGER NEEDED FOR PUBLIC USE USING THE ONLINE AUCTION SERVICES OF GOVDEALS

WHEREAS, the auction of this surplus personal property will begin at 9 a.m. prevailing time on September 29, 2025, and conclude at 4 p.m. prevailing time on October 6, 2025; and

WHEREAS, the sale is being conducted pursuant to N.J.S.A. 40A:11-36, N.J.A.C. 5:34-5.8, and the guidance set forth in the Division of Local Government Services' Local Finance Notice 2019-15;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Clinton, County of Hunterdon, State of New Jersey, as follows:

- 1. The Township is hereby authorized to sell the surplus personal property listed on Schedule A using the online auction website entitled GovDeals, located at GovDeals.com.
- 2. The surplus property identified on Schedule A shall be sold in an "as-is" condition without express or implied warranties, and the successful bidder

- required to execute a Hold Harmless and Indemnification Agreement concerning use of said surplus property.
- 3. The Township reserves the right to reject all bids if such rejection is in the public interest.
- 4. The terms and conditions of the agreement entered into between GovDeals and the Township are available at GovDeals.com and in the Township Clerk's office.
