## A RESOLUTION TO ACCEPT FUNDS FROM THE TRANSPORTATION AGENCY FOR 2023 NEW JERSEY DEPARTMENT OF TRANSPORTATION TRUST FUND GRANT CHAPTER 159

WHEREAS, NJSA 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the Budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

**WHEREAS**, said Director may also approve the insertion of an item of appropriation for an equal amount; and

WHEREAS, the Township of Tewksbury has been awarded \$209,190.00 from The Transportation Agency for 2023 NEW JERSEY DEPARTMENT OF TRANSPORTATION TRUST FUND GRANT

**WHEREAS**, the Township of Tewksbury wishes to amend its 2023 Budget by an additional \$209,190.00 to include this amount as a revenue.

**NOW, THEREFORE, BE IT RESOLVED**, that the Township Committee of the Township of Tewksbury, County of Hunterdon, State of New Jersey hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the Budget of the year 2023 in the sum of \$209,190.00 which is now available as a revenue from:
