**A RESOLUTION AWARDING CONTRACT: BID #B01-2026 – TOWNSHIP GROUNDS  
MAINTENANCE**

**WHEREAS**, the Township of Tewksbury (“Township”) advertised for sealed bids for Bid #B01-2026, Township Grounds Maintenance, in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

**WHEREAS**, two (2) sealed bids were received and publicly opened on February 18, 2026 at 10:00 a.m.; and

**WHEREAS**, Pat’s Lawn Care Inc., 3 Dalrymple Way, Frenchtown, NJ 08530 and High Tech Landscapes, Inc., Branchburg, NJ 08876 submitted bids; and

**WHEREAS**, the Township has reviewed the bids received and has determined the lowest responsible and responsive bidder based on the Base Bid (required services) submitted on the Pricing Worksheet; and

**WHEREAS**, the Base Bid submitted by Pat’s Lawn Care, Inc., in the amount of \$57,600.00, is the lowest responsible and responsive bid; and

**WHEREAS**, Pat’s Lawn Care, Inc. also submitted unit pricing for Optional/On-Call services that may be authorized by the Township from time to time; and

**WHEREAS**, the Chief Financial Officer has certified that funds are available for this award in budget account 10RE84;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Tewksbury, County of Hunterdon, State of New Jersey, as follows:

1. The contract for Bid #B01-2026, Township Grounds Maintenance, is hereby awarded to Pat’s Lawn Care, Inc., 3 Dalrymple Way, Frenchtown, NJ 08530, in the Base Bid amount of \$57,600.00.
2. Optional/On-Call services, if and only if authorized in writing by the Township, shall be provided at the unit prices set forth in the Contractor’s Pricing Worksheet. The Township’s total authorization for Base Bid plus Optional/On-Call services shall not exceed \$65,000 unless increased by further action of the Township Committee and subject to available appropriations.
3. The Mayor, Township Clerk, and/or other authorized officials are hereby authorized to execute the contract documents and all necessary paperwork to effectuate this award.
4. This award is contingent upon the Contractor’s continued compliance with all bid requirements, submission/maintenance of required insurance, and any other contract conditions set forth in the bid specifications.
