**RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF CLINTON
APPROVING AND AUTHORIZING THE EXECUTION OF A NEW COLLECTIVE
NEGOTIATIONS AGREEMENT BETWEEN THE TOWNSHIP OF CLINTON AND THE
FRATERNAL ORDER OF POLICE, LODGE NO. 182 FOR THE PERIOD 2023-2026
(PATROL OFFICERS)**

WHEREAS, representatives of the Township of Clinton and the Fraternal Order of Police, Lodge 182 (“F.O.P.”) have agreed upon the terms of a new collective bargaining agreement between the Township and the F.O.P. covering the Clinton Township Police Department’s full-time permanent patrolmen and corporals for the period January 1, 2023 through December 31, 2026, entitled “Collective Negotiations Agreement between the Township of Clinton and the Fraternal Order of Police, Lodge No. 182, January 1, 2023 through December 31, 2026” and dated January 22, 2026 (the “CNA”), a copy of which is attached hereto as Exhibit A and made a part hereof; and

WHEREAS, the CNA has been reviewed and approved as to form and substance by the Township’s Labor Counsel; and

WHEREAS, the CNA has been signed by the President of the F.O.P.; and

WHEREAS, the Mayor and Council are satisfied that the terms of the CNA are consistent with and correctly implement the terms of the Memorandum of Understanding that was signed by representatives of the Township and F.O.P. on October 31, 2024 and ratified by the Township Mayor and Council on November 13, 2024 (see Resolution No. 2024-232), and therefore wish to authorize its execution;

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Clinton, in the County of Hunterdon, State of New Jersey, as follows:

1. The preamble to this resolution is hereby incorporated as if more fully set forth herein.
2. The agreement entitled “Collective Negotiations Agreement between the Township of Clinton and the Fraternal Order of Police, Lodge No. 182, January 1, 2023 through December 31, 2026” and dated January 22, 2026, which agreement covers all full-time, permanent patrolmen and corporals of the Clinton Township Police Department (see Exhibit A attached hereto), is hereby approved,

and the Mayor and Clerk are hereby authorized and directed to execute same on behalf of the Township.

3. This resolution shall take effect immediately.
