**RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF CLINTON  
APPROVING A CONTRIBUTION AND USE AGREEMENT WITH THE OWNER OF THE  
FOUNTAIN MOTEL FOR THE INSTALLATION OF A 'FLOCK' SECURITY CAMERA**

**WHEREAS**, Clinton Township is the owner/lessor of "Flock" law enforcement security cameras supplied by the Flock Group, Inc. of Atlanta, Georgia; and

**WHEREAS**, due to numerous law enforcement incidents at the Fountain Motel in Clinton Township, the Clinton Township Department Police ("CTPD") has recommended that a Flock security camera and related equipment be installed at the Motel for law enforcement purposes; and

**WHEREAS**, the Township will retain ownership of the data and will have sole access to the Flock Safety Portal and all data recorded by the Camera, including video and license plate recognition ("LPR") information; and

**WHEREAS**, the data shall be accessed by the CTPD only, and shall be used by the CTPD solely for security and law enforcement purposes and in full compliance with all applicable laws as well as Flock Safety's terms of Service; and

**WHEREAS**, the annual cost of the camera and related equipment is \$3,500.00; and

**WHEREAS**, the owner of the Fountain Motel recognizes the benefits of having a Flock security camera on the premises, and to that end has agreed to contribute \$2,500.00 per year toward the costs of installing and maintenance the camera and related equipment; and

**WHEREAS**, the Chief of Police has indicated that the balance of the costs will be paid for using DEA funds; and


**WHEREAS**, the Mayor and Council deem it advisable to memorialize the terms of the arrangement between the CTPD and the Fountain Motel by entering into a contribution and use agreement with the owner of the motel;

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Township of Clinton, County of Hunterdon, State of New Jersey as follows:

1. The preamble to this resolution is hereby incorporated as if restated in full.

2. The Mayor or Chief of Police are hereby authorized to execute on behalf of the Township the Contribution and Use Agreement attached hereto and made a part hereof.
3. The Mayor, Chief of Police, Acting Clerk, Administrator, Attorney, and any other municipal officials that may be appropriate, are hereby authorized and directed to sign any documents and undertake any acts necessary to effectuate the terms of this resolution.
4. This resolution shall take effect immediately.


