On 9-27-2025 at 1227 hours, I was on duty, in uniform displaying the badge office in the Village of Bosque Farms, Valencia County, State of New Mexico. I was dispatched to the residence of 260 Del Norte Court, in the Village of Bosque Farms NM for a report of stalking and harassment.

Upon arrival I met with Eric Granzberg, the caller, in the front of his fence where the walk-through gate is for his mailbox. Fintroduced myself to Eric, as he did also. We had a long conversation about the previous issues he has been dealing with, involving about 40 calls to his home in the last five (5) plus years of living at this address, by the village law enforcement/ planning and zoning, etc. During this time, I learned that he has a police report from 2020 on file he wanted to add information to. (Later, it was found to be an Officer report (not criminal in nature), case # 202000108, Bosque Farms Police, dated 3/07/2020.) I did not know the information that was contained in this report while speaking with Eric, but I advised Eric that this is an old report that is still "active" (meaning that the officer that took the report did not close the case). I explained that this incident would possibly need to be started over as years have passed for what he was describing as a background of information along with the Statute of Limitations issues with other things can get a bit confusing over time, and he eventually agreed it would be ok to move forward with the issue at hand he wanted to report on a new report.

Eric is conveying information over the past years about an HOA (Home Owners Association) issue starting up in the neighborhood that never existed before, and issue with Dolly Wallace (an ex elected Village council woman for the Village of Bosque Farms, along with being the ex-elected Village of Bosque Farms Municipal Judge, who is currently a candidate in an election for a Village Counsel seat at this time), the Dixon's (south fence neighbor) who are related to the Village Municipal Attorney, Mark Jarmie. This is all background information of the persons Eric is giving me information about. Although I can confirm the roles described for Dolly personally, I cannot confirm the relations of the Dixons to Mark, who is the Village of Bosque Farms Attorney.

Also brought up by Eric is that he has an ongoing litigation issue in federal court systems, with the help of retained counsel of an attorney, revolving around past an ongoing conduct he is describing. He is active in obtaining records through "IPRA" (Inspection of Public Records Act) requests and he is bringing forth what he describes as behavior that is

unlawful against him by village residents, person(s), and village government elected/appointed/contracted employees (past and present).

We spoke about this for a bit of time as I was getting a description of what led me out to his home today to speak with him. He says he has a recorded phone conversation between Dolly Wallace and Erica DeSmit in his possession that is electronic in his phone. I ask how this recording was obtained, and he says he got it from a "Third Party". He says that it was from the recording that Erica made of a phone conversation with Dolly, but he did not get it from Dolly. He was then able to get it through this third-party contact for his usage. He was not forthcoming in who this third party was by name or entity.

At one point, Eric played a recording of a phone conversation, that he prefaces for setting who was involved in this conversation, and the context of what his complaint was. He describes the call as from Dolly Wallace to the Village of Bosque Farms Council woman Erica DeSmit, a sitting council woman at this time, not previous or involved in a current election cycle, as she is midway through her elected four (4) year term.

Eric was cordial in his statement about this matter.

The nature of his complaint involves what was said over the phone that he feels is inaccurate and derogatory in nature about him. In listening to this recording, with no titles of office mentioned by either Erica or Dolly, Dolly described Eric as being a "colorful little boy from the past", as Erica says she has been seeing the IPRA's coming though and stuff online and wanted to know what is going on. Dolly continues stating she "thinks" that Eric is a "Vietnam Vet" (veteran), "who has some mental issues", says Eric is "doing atrocities" to his neighbors (her friends the Dixon's), accusing Eric of watching Ms. Dixon through her home window over the common fence with drones (aerial remote control aircraft) when Mr. Dixon is not home from a camper and Eric playing and making loud noises and sounds. Dolly describes a "big fight" (disagreement) with the ex-mayor of the Village of Bosque Farms, Wayne Ake, over no action being taken against Eric by using laws she had found, and Dolly was told it was a civil matter. Dolly says she told Wayne if it was his wife, he would want something done about it. The call ends with Dolly describing Eric as being married, being on his property in the evenings with his lights on, a small fire, and carrying on. The call ends with Erica answering a call for her husband that was calling her.

#### 30-3A-2 NMSA 1978-

Harassment consists of knowingly pursuing a pattern of conduct that is intended to annoy, seriously alarm or terrorize another person and that serves no lawful purpose. The conduct must be such that it would cause a reasonable person to suffer substantial emotional distress.

At this point I was not immediately concerned about an immediate threat nor was any of these relayed by Eric as his concern in this reported phone call or incident.

# 30-3A-3 NMSA 1978-

A. Stalking consists of knowingly pursuing a pattern of conduct, without lawful authority, directed at a specific individual when the person intends that the pattern of conduct would place the individual in reasonable apprehension of death, bodily harm, sexual assault, confinement or restraint of the individual or another individual.

#### B. As used in this section:

- (1) "lawful authority" means within the scope of lawful employment or constitutionally protected activity; and
- (2) "pattern of conduct" means two or more acts, on more than one occasion, in which the alleged stalker by any action, method, device or means, directly, indirectly or through third parties, follows, monitors, surveils, threatens or communicates to or about a person.

At this point I was not immediately concerned about a pattern of conduct that would place the individual (Eric) in reasonable apprehension of death, bodily harm, sexual assault, confinement or restraint of the individual or another individual, nor was any of these issues relayed by Eric as his concern in this reported phone call or incident.

A step further involves:

Libel

30-11-1 NMSA 1978

Libel consists of making, writing, publishing, selling or circulating without good motives and justifiable ends, any false and malicious statement affecting the reputation, business or occupation of another, or which exposes another to hatred, contempt, ridicule, degradation or disgrace.

The word "malicious," as used in this article, signifies an act done with evil or mischievous design and it is not necessary to prove any special facts showing ill-feeling on the part of the person who is concerned in making, printing, publishing or circulating a libelous statement against the person injured thereby.


- A. A person is the maker of a libel who originally contrived and either executed it himself by writing, printing, engraving or painting, or dictated, caused or procured it to be done by others.
- B. A person is the publisher of a libel who either of his own will or by the persuasion or dictation, or at the solicitation or employment for hire of another, executes the same in any of the modes pointed out as constituting a libel; but if anyone by force or threats is compelled to execute such libel he is guilty of no crime.
- C. A person is guilty of circulating a libel who, knowing its contents, either sells, distributes or gives, or who, with malicious design, reads or exhibits it to others.
- D. The written, printed or published statement to come within the definition of libel must falsely convey the idea either:
  - (1) that the person to whom it refers has been guilty of some penal offenses;
  - (2) that he has been guilty of some act or omission which, though not a penal offense, is disgraceful to him as a member of society, and the natural consequence of which is to bring him into contempt among honorable persons;
  - (3) that he has some moral vice or physical defect or disease which renders him unfit for intercourse with respectable society, and as such should cause him to be generally avoided;
  - (4) that he is notoriously of bad or infamous character; or
  - (5) that any person in office or a candidate therefor is dishonest and therefore unworthy of such office, or that while in office he has been guilty of some malfeasance rendering him unworthy of the place.
- E. It shall be sufficient to constitute the crime of libel if the natural consequence of the publication of the same is to injure the person defamed although no actual injury to his reputation need be proven.

F. No statement made in the course of a legislative or judicial proceeding, whether true or false, although made with intent to injure and for malicious purposes, comes within the definition of libel.

Based on the listed definition of libel, there may be cause for Eric to pursue his own charges in the Magistrate court system should he choose to do so and prove his case.

On 10-01-2025, I did print and attach multiple emails from Eric Granzberg to my case file that I received from him through <u>j.gordon@bosquefarmsnm.gov</u> as follows,

All these above items listed in (1-6) were either added to this police report for further reference in the future/ or taken into evidence for storage.

On 10/02/2025 at 1105 hours, I called Erica DeSmet and spoke to her over the phone about the phone call recording that was presented to me by Eric Granzberg. Erica was at the gym during this call and we spoke about the taped call and its authenticity. She recalls the conversation with Dolly Wallace but did not give a date of that call. She says she does record all her phone conversations and does keep them, along with distributing them to several unidentified people, including her attorney. She does not know who may have gotten that recording or how it got transmitted to Eric Granzberg. She was cordial in her statement about this matter.

On 10/02/2025 at 1132 hours, I spoke to Dolly Wallace in person at her home about the phone call recording that was presented to me by Eric Granzberg. She says she just got off the phone with Erica DeSmet before I arrived at her home. In authenticating this recording, she did authenticate this recording by listening to it, later in this interview. We spoke in depth about the nature of that call and how this issue came about, revolving around Dixon's issues with Eric. Dolly says she did not name Eric specifically in this recorded

phone conversation. I explained to her that Eric is not old enough to be Vietnam veteran, and other statements about Eric could cause her to receive ramifications through court actions and she needs to begin distancing herself from Eric, and that the correct way for this neighbor situation to take any legal form of resolution would be for the Dixon's to seek civil remedies through the courts. She eventually agreed with this and understands. I encouraged her to leave herself free of involvement with this neighbor dispute.

Dolly feels this release of the phone call recording may have been politically motivated as there was not a current issue with Eric until she announced her candidacy for village counsel on or about 8/21/2025 in a village counsel meeting. She says this recorded phone call had happened in very close proximity to that announcement.

As we spoke for an amount of time, I learned this issue is an ongoing issue over the years and she is good friends with the Dixon's. She did bring up the YouTube (an internet based public video sharing platform) video from 2020 that is posted from being outside of Eric's home in the roadway and showed it to me. (I downloaded a copy of this video recording described from YouTube and placed it into evidence in this case). Again, she was encouraged to leave the Dixon-Granzberg neighbor dispute to those parties involved, as she is not a neighbor involved, and she does not live in immediate proximity to them either.

Other items were also discussed in this investigation that did not immediately relate back to the matter at hand, which was the phone recording Eric called to file a report on. The interview ended and the entire encounter with Dolly was cordial.

Based on the report made by Eric, I did not find reason to pursue charges, or a summons, at this time based on Harassment or Stalking, but if any party involved feels they would like to file a cause of some sort in a Court, that would be their own option.

On 10/03/2025 at 1006 hours, I called Eric and spoke with him about meeting him to give him an update on this report. He said he was home, and I advised I would come by in about five (5) minutes to see him.

On 10/03/2025 at 1013 hours I met with Eric outside of his home at 260 Del Norte Court. In this conversation. I explained that I had spoken to Erica and Dolly. The phone call was conformed to be authentic by both. I explained to Eric the information that was provided by both Erics and Dolly in short. I also explained that based on his complaint of harassment and stalking, this incident did not appear to fit the requirements of these statutes. However, under libel (30-11-1 NMSA 1978), this complaint/ report may or may not fit that statute. This would be for him to decide what he would want to do about his desired outcome of this report as to a criminal, civil, or not pursue any legal remedy. He understood and was thankful for the information. He was cordial during our time spent about this issue.

Video/ audio recordings from body cams are tagged into evidence.

At this time, this report is closed with no further action contemplated by the reporting officer.
