

Summary of Ordinance No.(s) 046-25, 048-25, 049-25, 050-25 and Resolution No.(s) 047-25, 051-25, 052-25, 053-25

Ordinance No. 046-25

An Ordinance establishing the appropriation measure (budget) of the City of Napoleon, Ohio for the fiscal year ending December 31, 2026, listed in Exhibit A; and declaring an Emergency In this legislation, the City of Napoleon established a budget for the 2026 fiscal year.

Ordinance No. 048-25

An Ordinance amending the allocation of funds as found in Sections 193.11 and 194.013 of the Codified Ordinances of the City of Napoleon, Ohio; and declaring an Emergency

In this legislation, the City of Napoleon amended the allocation of

Ordinance No. 049-25

An Ordinance apportioning the expenses incurred including wages, salaries and fringe benefits of the Mayor, Council, and various other departments of the City of Napoleon which are not otherwise directly charged to special and/or capital projects among various accounts effective January 1, 2026; amending Ordinance No.(s) 104-09, 087-19, 069-20, 059-21, 076-22, and 048-23; and declaring an Emergency

In this legislation, the City of Napoleon apportioned various expenses from City departments which are not directly charged to special and/or capital projects.

Ordinance No. 050-25

An Ordinance establishing a new position classification pay plan for employees of the City of Napoleon, Ohio for the year 2025; repealing Ord. No. 049-23; and declaring an Emergency

In this legislation, the City of Napoleon established a new pay plan for City employees.

Resolution No. 047-25

A Resolution authorizing the Finance Director to transfer certain fund balances from respective funds to other funds per ORC. Section 5705.14 on an as needed basis in fiscal year 2026, listed in Exhibit A; and declaring an Emergency

In this legislation, the City of Napoleon authorized the Finance Director to transfer certain fund balances as needed in fiscal year 2026.

Resolution No. 051-25

A Resolution authorizing a contribution to the Community Improvement Corporation of Henry County, Ohio, in and for the year 2025; and declaring an Emergency

In this legislation, the City of Napoleon authorized a contribution to the CIC.

Resolution No. 052-25

A Resolution authorizing the expenditure of funds and authorizing a department director to take bids on certain projects, services, equipment, materials, or supplies without the requirement for additional legislation to do so in the year 2026; and declaring an Emergency

In this legislation, the City of Napoleon authorized the expenditure of funds and City Department Directors to take bids on certain projects, services, equipment, materials or supplies without additional legislation in the year 2026.

Resolution No. 053-25

A Resolution authorizing expenditure of funds in excess of fifty thousand dollars (\$50,000) in and for the year 2026 as it relates to reoccurring costs associated with the operation of the City, for payment of expenses, and for purchases associated with vendors utilized by multiple departments within the City; elimination of necessity of competitive bidding in and for the year 2025 as it relates to certain transactions; and declaring an Emergency

In this legislation, the City of Napoleon authorized the expenditure of funds for reoccurring costs associated with the operation of the City in the year 2026.
