

LEGAL NOTICE-Fees Effective 1/1/26

At a recent meeting, the Fulton County Board of Health adopted the following local fees for the Environmental programs listed below, effective 1/1/26. Food Service Operation/Retail Food Establishment annual license: level 1 small \$180, level 2 small \$204, level 3 small \$429, level 4 small \$548, level 1 large \$270, level 2 large \$286, level 3 large \$1,100, level 4 large \$1,166, mobile \$224, low-risk mobile \$112, temporary \$57, vending \$19.15, plan review \$216. Annual license for public swimming pool, spa and special use pool is \$172. Additional pool, spa, special use pool at same location \$108. Water samples collected by health department lab cost plus \$40. Client collected lab cost plus \$30. Installation permit for new Private Water System (PWS) pond for a single-family dwelling (SFD) is \$338. Installation permit for new SFD PWS is \$312. Alteration permit for PWS or test well for SFD \$252. Time Limited hauled water storage tank, sealing or alteration/disconnection and retain use of PWS \$61. Permit for construction of a test well \$312. Permit for conversion of a non-PWS well to SFD PWS is \$252. Permit for conversion of non-PWS well to non-SFD PWS well \$267.
