Phase B is a structural overlay of Hallett Avenue from the existing pavement joint north of church street to the bridge of the I-80/I-90 overpass (2400 +/- Feet.) The project includes milling 3 inches of pavement and application of a two-course overlay with pavement repairs. Work includes removal and replacement of curb and gutter. The project also will include new ADA compliant walk, curb ramps, and crosswalks along the west side of the roadway to the north side of Elm Street.
