The Village of Swanton, Ohio, (Owner) is requesting Bids for the construction of the following Project:
FUL-US 20A-25.92 Airport Highway Signals Kleinfelder Project No. 24003120

Bids for the construction of the Project will be received at the Village of Swanton Administrative Building located at 219 Chestnut Street, Swanton, Ohio, 43558, until:
10:00 am (Local Time) Tuesday, December 16, 2025

At that time the Bids received will be publicly opened and read.

The Project includes the following Work: Safety-related improvements at two intersections in the Village of Swanton, Ohio: Hallett Avenue & Airport Highway (US-20A); and Main Street & Airport Highway (US-20A). Improvements include upgrading existing permitted left turn lanes to protected left turn lanes, upgrading signal heads and supports, and modifying lane arrangement for westbound traffic at Main Street and Airport Highway.

Only ODOT pre-qualified contractors are eligible to submit bids for this project. Pre-Qualification status must be in force at the time of the bid, at the time of award, and through the life of the construction contract. Bidders are also expected to provide an experience statement indicating their ability to perform the work as required in the contract documents.

Bidding Documents may be downloaded from the designated website. Documents may also be obtained from Becker Impressions, 4646 Angola Road, Toledo, Ohio 43615, Telephone 419-385-5303. Prospective Bidders must register with the designated website as a plan holder, even if Bidding Documents are obtained from a plan room or source other than the designated website in either electronic or paper format. The designated website will be updated periodically with addenda, lists of registered plan holders, reports, and other information relevant to submitting a Bid for the Project. All official notifications, addenda, and other Bidding Documents will be offered only through the designated website.

Neither Owner nor Engineer will be responsible for Bidding Documents, including addenda, if any, obtained from sources other than the designated website. Failure to submit a complete set of documents could result in a bid that is determined to be nonresponsive and rejected by the Owner.

Prospective Bidders may obtain or examine the Bidding Documents at the Issuing Office on Monday through Friday during regular business hours. Partial sets of Bidding Documents will not be available from the Issuing Office. The cost of printing is to be paid to the printing company at the time the drawings are picked up. Shipping and tax charges are the bidder's responsibility and payable directly to Becker Impressions.

Bid Guaranty

The bid guaranty may be of two forms:

1. A Bid Guaranty and Contract Bond using the form in the Contract Documents. (The amount of the bid does NOT have to appear on this form.)
2. A certified check, cashier's check or letter of credit in favor of the Village of Swanton, Ohio, in the amount of 10% of the bid. If the contract is awarded, a Contract Bond will be required, which is a 100% payment and performance bond.

After the award of the contract let by competitive bid and prior to the time the contract is entered into, bidders shall submit the affidavit required under the Ohio Revised Code, Section 5719.042 that the bidder was not charged with any delinquent personal property taxes in Fulton County, Ohio.

The Village of Swanton, Ohio, reserves the right pursuant to ORC.9.312 to reject any and all bids and to waive any non-material irregularity in determining the lowest responsive and responsible bidder.

Instructions to Bidders

The Engineer for the Project is Kleinfelder, Inc., 5201 Levis Commons Boulevard, Suite 5201, Perrysburg, Ohio 43551.

All bids must be signed and submitted on the blanks which are bound in this booklet. Bids must state the unit prices in the blanks provided and be enclosed in a sealed envelope marked — FUL-US 20A-25.92 Airport Highway Signals — and addressed to the Village of Swanton, Ohio, Attn: Shannon Shulters, Village Administrator at 219 Chestnut Street, Swanton, Ohio 43558.

No bidder may withdraw their bid for a period of 60 days after the scheduled closing time for the receipt of bids.

The successful bidder will be required to pay federally determined Davis-Bacon Wage Rates.

For all further requirements regarding bid submittal, qualifications, procedures, and contract award, refer to the Instructions to Bidders that are included in the Bidding Documents.

The Engineer's opinion of probable cost for this project is \$321,200.00.
