Did you know that cooking grease is the main cause of most residential pipeline and City collection system blockages? These blockages can result in sewer spills throughout the City. Cooking grease coats the inside walls of sewer pipes, similar to the way fatty foods can clog your arteries. The grease that clings to the pipes builds up over time and acts as a host for other materials to cling to, restricting the size of the pipe even more. Eventually the pipe becomes completely clogged and sewer will back up either in the homeowner's yard or through a manhole into the City streets and possibly to streams.
By doing a few simple things in your home or business, you can help prevent costly

sewer spills and reduce environmental impacts associated with spills. Listed below are things to remember:
• All cooking oils (including salad oil, frying oil, bacon fat, and marinades) need to be poured into a container. The container can be an old milk carton, frozen juice container or other non-recyclable container and disposed of in the garbage. You may use cat litter or used coffee grounds to absorb the liquid in the container.
• Dry wipe all pots and dishes. Use a paper towel or napkins to remove greasy leftovers from pots and dishes prior to washing in the sink or dishwasher.

• Whenever meat is drained in a colander, place the colander over newspaper instead of the sink, and then throw the newspaper away.
