will be held before the Bolton Town Council in order to solicit citizen input in the development of a 2026 Community Development Block Grant Neighborhood Revitalization Program (CDBG-NR) Application. CDBG-NR funds can be used for a variety of different activities in support of the North Carolina Department of Commerce's Rural Economic Development Division's three livability principles: (1) Promote equitable, affordable housing; (2) Support existing communities; and (3) Value communities and neighborhoods. Eligible activities must meet at least one of the three CDBG national objectives to be eligible: (1) benefit low-and-moderate income (LMI) persons; (2) prevent or eliminate slums or blight; or (3) meeting other community development needs that are deemed to be urgent because of existing conditions that pose a serious and immediate threat to the health and welfare of the community, and other financial resources are not available to meet the need. The United States Environmental Protection Agency announces a 30-day comment period and availability of the Administrative Record (AR) for the Engineering Evaluation/Cost Analysis (EE/CA) for the Wright Chemical Corporation Superfund Site (Site) located at 333 Neils Eddy Road, Riegelwood, Columbus County, North Carolina. This EE/CA describes the proposed cleanup alternatives for a Non-

LEGALS

Time-Critical Removal Action (NTCRA) for the Site. A 30-day comment period, beginning on April 20 and ending on May 19, 2026, is offered for public input on the cleanup alternatives being proposed for specific areas within the Site. These actions are to address impacted soils and the on-site landfill. The proposed alternatives being presented for review and comment are found in the EE/CA at: www.epa.gov/superfund/wright-chemical
 The Site has been used to produce fertilizer and specialty chemicals since the 1880s. Fertilizer manufacturing operations were done by various parties between the 1880s and 1984. Fertilizer manufacturing ended in 1984, and certain plant buildings at the Site were torn down. Chemical production operations continue on property north of the railroad tracks on Site. The Site was added to the National Priorities List (NPL) in 2011. Beginning in 2014, a Remedial Investigation (RI) was conducted which showed elevated levels of lead and arsenic in soil in an area identified as Study Area 1 and elevated levels of Radium-226 in soil in the area identified as Study Area 6. Further, engineering evaluations determined that repairs to the Monofill Cell (the on-site landfill) were needed. The EPA determined that these specific areas would be best addressed by a NTCRA action. The EE/CA for the proposed removal alternatives was finalized in March 2026.
