I offer the following resolution and move its adoption:

1 A SENATE RESOLUTION honoring Senator Frank Mrvan
2 for his service to the Indiana Senate.

3 *Whereas, Senator Mrvan has faithfully and honorably*
4 *served the constituents of Senate District 1, encompassing*
5 *portions of Lake County, for 39 years;*

6 *Whereas, Senator Mrvan served from 1978 to 1994, and*
7 *again from 1998 to 2022;*

8 *Whereas, Senator Mrvan was an Airman 1st Class in the*
9 *United States Air Force during the Korean War;*

10 *Whereas, Prior to his election to the State Senate, Senator*
11 *Mrvan was the President of the City Council of Hammond for*
12 *ten years;*

13 *Whereas, During his tenure, Senator Mrvan served on a*
14 *variety of committees, including Local Government, Insurance,*
15 *Homeland Security and Transportation, Veteran Affairs and*
16 *The Military, Education and Career Development, Ethics,*
17 *Health and Provider Services, Agriculture, Natural Resources,*
18 *Tax and Fiscal Policy, Commerce, Economic Development, and*

5 *accomplishments include strengthening protections for*
6 *children, expanding veterans' benefits and employment,*
7 *working to lower the tax burden on senior citizens, and passing*
8 *legislation to make transportation safer and more efficient*
9 *statewide;*

11 *Mrvan was awarded the Legislator of the Year Award by the*
12 *Indiana School Counselor Association in 2019 and was named*
13 *a Small Business Champion in 2011 by the Indiana Chamber of*
