STATEMENT REGARDING THE MURDER OF A JOHN DOE  
NEAR LAKE VILLAGE INDIANA IN JULY 1983

I, LARRY EYER, confess to the murder of an unidentified black male in his late teens or early 20's in mid-July of 1983 at an abandoned farmhouse near Lake Village Indiana. I committed this murder alone but I later described the murder to Robert David Little of Terre Haute Indiana. I took the person's shirt to Little, Little paid me money for doing this murder.

Sometime around the first week of July I learned that my lover John Dobrowolskis had been having sex with a former lover of mine Michael Olds. This situation was very hurtful to me and made me extremely angry. I know that I tried to call John and Michael Olds from Greencastle the night before the murder which occurred during the early morning of the next day. I was so angry that I started to drive back to Chicago - I think on a Sunday. I drove to Terre Haute and talked to Dave Little. He knew how upset I was and he said "well there's one thing you can do which will make you feel better." I started driving on 63 north to 41 north. I saw a black guy hitchhiking. I think he was in his late teens or early 20's. I

asked him if he would let me tie him up and suck him off for \$75. He thought about it and said "ok." I headed back to the old farmhouse by Lakeville. It was real late when we got there - probably at least 4 A.M. I was drinking vodka and so was this individual. I offered him a Placidyl and he took it. When we got to the farmhouse I tried to park the truck so it would not be seen. We walked up to the farmhouse. I told him I needed to tie him to a beam or post. I tied him to the same structure that I tied the unidentified caucasian male to. I blindfolded his eyes with an Ace bandage. I put duct tape around his head covering his mouth. I tied his feet with a rope. I handcuffed him. I pulled his pants to his knees. I said "ok, motherfucker, make your peace with God." After waiting 4-5 minutes I stabbed him repeatedly in the stomach and chest. He slumped forward and I knew he was dead. I cleaned up the scene. I took his wallet and tore it up and threw it out of the truck window.

I drove to Highland Indiana and stopped to call Dave Little from a pay phone. He said [about the victim] "Did he grunt or did he groan?"

I called Dave Little again from the Cook County Hospital because I cut my hand when I was stabbing this person. I got stitches I think but I'm not sure.

When I made a grave for this individual I seperated him from the other 3 bodies because I did not think it was proper to bury this person next to the other

3 Caucasian men. I have given this statement fully and voluntarily to my attorney \* Also I know I called Dr. John Keredes to get more placcidyl after this murder

STATEMENT REGARDING THE MURDER OF JOHN DOE NEAR LAKE VILLAGE INDIANA in MAY 1983

I, Larry Eyer, confess to the murder of an unidentified caucasian male in mid to late May of 1983. This person was killed in an old farmhouse close to Lake Village in Newton County Indiana. I do not know the exact date of the killing but I think Robert David Little, who was involved in this murder, was on sabbatical from his job at Indiana State University.

I had been fighting all week-end with my lover John Dobrowolskis. I'd decided to drive back to Terre Haute, Indiana and stay with Little. Little hated Dobrowolskis and was always trying to get me to leave him. Dave Little began talking to me about killing people about 6 months before the Steven Crockett murder. Dave was present at 5 of the murder scenes. He alone killed Denny Bridges and he & I together killed 4 additional people. He knew the details of all of the murders. I brought him the victims t-shirts. In exchange he gave me money and gifts and took me on trips. He was very nice to me almost like a father and

I bear him no ill-will. I killed 17 people alone so I'm worst than he is but in order to tell the truth about these crimes I have to describe Dave Little's part in them.

I remember being in Greencastle on the date of this murder. When I returned to Little's townhouse on Keane lane this 20-25 year old caucasian male was at the townhouse with Dave Little. I think this person was about my height, thin and not good-looking. Little always had to pay for sex and usually or many times the men he had sex with were not good-looking. Little said he had picked this guy up earlier but he didn't say where. Little took this guy to his bedroom for awhile. Little came out and told me he had talked this guy into doing a "wild scene" at the farmhouse outside of Lake Village in Newton County. Little knew about the murders of Bartlett and Bauer because I brought their shirts to him. Little said he was bringing his Polaroid with a flash and his Nikon. He told me to get the murder bag out of the garage. He took my truck. I offered this guy beer which he drank. I took guacalades

I offered him placidyl but Dave shook his head no. He wanted this guy awake when he killed him. This person seemed sort of dumb to me. I couldn't tell if he had been at Little's townhouse before - they seemed sort of familiar but no mention was made of any prior meetings at Little's townhouse.

Dave showed him a \$100 bill that he kept in a bag in the front seat. Dave told him "we're looking for something really far out." He said "we want to tie you to this post <sup>or tree</sup> ~~at~~ at the farmhouse and one of us will suck you off while the other takes pictures." This person said he didn't know if he wanted to but Little said "we'll give you \$100." This person said "ok I need the money."

We drove up 63 north to 41 north until we got to the old farmhouse. I parked the truck so that it couldn't be seen from the road. We picked a spot where these 2 by 4's looked like a cross. Dave said this would be a good place to tie him up.

I got the rope out of the bag. Dave set up the flashlights to shine on this person. I worked real fast. I tied his feet with the rope; I wrapped duct tape around his head 3-4x, I handcuffed his hands behind him. Dave had already started masturbating. He would always say "Get his eyes, get his eyes." I put an ace bandage around his eyes. He stayed still at first.

Dave said "ok, stand next to him and put the knife against his stomach after you pull his shirt up. I did this and he began to squirm. Dave snapped a picture! said 'Pull his pants down.' I had to struggle with this person because he seemed to know something was wrong. I pulled his pants down to his knees. Dave took a picture of this. Dave said "ok, kill the motherfucker." This person really began to struggle which really excited Dave. I said to this person "Ok, make your peace with God, motherfucker". I

thought about John Dobrowolskis and I felt an enormous rage building up inside of me. I started stabbing, stabbing, blood was everywhere by this time Dave had come all over the ground. He rushed forward and grabbed the knife in my hand. He started stabbing this person until his body slumped forward.

Dave said "take him down." I untied his feet, took the <sup>(duct tape)</sup> gag out of his mouth, the ace bandage off his eyes, the rope and handcuffs off of him. Dave said lay him out on the ground. Dave had started masturbating again. I felt exhausted but I knew Dave wanted more so I kept stabbing this person. I think I hit him in the face too. I felt exhausted. Dave said we have to cut off his head with hands to prevent identification. He said "I don't want him connected to me." I can't remember

too much about this part but I cut the head and hands off this person - I used my knife and a hacksaw. We put the parts in a garbage bag and dumped it in a dumpster outside Terre Haute.

We went back to the townhouse in Terre Haute he washed our clothes, he never talked about the murders afterwards. Little would always send the pictures off to be developed to the same place. He used to say - they didn't care what they developed. Little would keep the pictures in a checkbook box in his closet. He would use these pictures and the victims clothes to masturbate.

After this murder Dave gave me money. He was always very good to me - like a father. He always gave me a home. I am not angry with him but I had to include him in this confession to make it truthful. I gave this statement voluntarily to my attorney to disclose upon my death.
