The Jackson County Carnival Association invites you to participate in the 50<sup>th</sup> anniversary | Mardi Gras Parade in Pascagoula on Saturday, February 14, 2026. **THE DEADLINE TO REGISTER IS January 23rd @ 6:30PM.**

An entry form, along with a list of "Do's & Don'ts" is enclosed. Position in the parade requires receipt of a **COMPLETED ENTRY FORM (pages 1 & 2)/ ENTRY FEE** along with **COPIES OF THE DRIVER'S INSURANCE CARD AND DRIVER'S LICENSE**. We will attempt to have the line-up published on Facebook in the Jackson County Carnival Assn group on the Friday prior to the parade. In the event of rain, the parade will be at 2:00 PM Sunday, Announcement of the delay will be made on local TV/Radio/Facebook by 9:30 Saturday FEBRUARY 14TH .

**THERE IS A MANDATORY DRIVERS/FLOAT CAPTAIN MEETING ON TUESDAY JANUARY 20, 2026 AT 6:30PM AT THE Pascagoula VFW POST 3373 LOCATED AT 4724 1ST LIEUTENANT EUGENE MAJURE DR. PASCAGOULA, MS . YOU MUST HAVE YOUR DRIVER(S) AND SOMEONE FROM YOUR FLOAT/KREWE IN ATTENDANCE OR YOU WILL NOT BE ALLOWED TO PARTICIPATE & YOUR ENTRY FEE WILL BE FORFEITED....NO EXCEPTIONS!!**

#### **DRIVER'S BRIEF, DOS & DONT'S**

**ALL FLOATS MUST BE IN LINE BY 10AM : AFTER 10 AM YOUR SPOT IS NOT GUARANTEED ALL DRIVERS MUST REGISTER 0.00 ON THE BREATHALYZER WHEN PASCAGOULA POLICE DEPT CHECKS... NO EXCEPTIONS!!** Be available @ your vehicle from the time it is parked until the parade starts moving @ 1PM. THERE WILL BE JCCA SECURITY AND OFFICERS ALONG THE ROUTE ASSURING ALL PARADE RULES ARE OBEYED!

1. All floats must have one, per level, approved fire extinguisher mounted and free from any obstructions. Fire extinguishers shall be tagged within 1 year, charged, and minimum size to be 2A/10BC. Fire extinguishers will be inspected at check in.
- 2. NO ONE IS ALLOWED TO RIDE IN/ON THE BACK OF ANY TRUCK PULLING A FLOAT/TRAILER.**
3. The parade will roll at a continuous speed (**LESS THAN 2 MPH**) to last 120 minutes. Please keep spacing consistent. Problems with spacing due to stopping, for other than safety reasons, may result in Entry being pulled from the parade or Entry not being accepted again.
- 4. NO ONE UNDER THE AGE OF 18 MAY PARTICIPATE IN THE PARADE ON FOOT UNLESS THEY ARE PART OF SCHOOL/MILITARY MARCHING GROUP (ROTC, ETC.)**
5. All Entries must enter the staging area at CANTY & DUPONT to your numbered area. You will return to the same space after the parade finishes. Pull off the roadway.
- 6. THIS IS A FAMILY EVENT. DO NOT HAVE MUSIC OR ACTIVITIES THAT ARE NOT APPROPRIATE FOR ALL AGES. ENTRIES MAY BE PULLED FROM THE PARADE FOR VIOLATIONS.**
7. For the safety of parade participants , be sure items thrown from the float are designed as throws. **ASK PARTICIPANTS NOT TO LITTER THE STAGING AREA OR ROUTE. DUMPSTERS ARE ALONG THE STAGING AREA. PLEASE DO NOT LEAVE TRASH BESIDE FLOAT OR ON THE STREET.**
- 8. DO NOT THROW ANY ALCOHOL, INCLUDING JELL-O SHOTS, OFF THE FLOATS.** We do not want any children picking them up. Do not throw any trash or empty boxes off your float. You WILL BE PULLED from the parade
9. No inappropriate music or inappropriate behavior. • No one under age 21 may participate in the parade on foot unless part of a Military/School marching unit.
10. • No riders in the bed of a pick-up truck.

  

- No 4-Wheelers are allowed in the parade line-up.
- Drivers of the vehicle pulling a float should NOT throw anything.
