

The charges read against Nathan Torian, transcribed from the Oct. 3 hearing are as follows:

CHARGE 1 - FAILS (3 NO; 2 YES)

Charge number one, exhibiting insubordination and disrespect to battalion chief Tinsman by referring to her as a lower rank during a call and later in a run report when you had actual knowledge of her proper rank. This behavior is in violation of Paducah code of ordinance, section two, dash, 313a, 1c. This motion is made to find Nathan Torian, Captain Paducah Fire Department guilty of charge 1.

CHARGE 2 - CARRIES (1 NO; 4 YES)

Charge number two exhibiting impoliteness and rudeness to battalion chief Tinsman by referring to her as a lower rank during a call and later in a run report when you had actual knowledge of her proper rank, this behavior is in violation of Paducah code of ordinance, section two, dash, 313, A, one, oh, this motion is made to find Nathan Torian, Captain Paducah Fire Department guilty of charge 2.

CHARGE 3 - FAILS (5 NO; 0 YES)

Charge number THREE, engaging in a dispute or quarrel with battalion chief Tinsman by referring to her as a lower rank during a call and later in a run report when you had actual knowledge of her proper rank. This behavior is in violation of Paducah code of ordinance, section two, Dash 313, A, one, this motion is made to find Nathan Torian, Captain Paducah Fire Department guilty of charge 3.

CHARGE 4 - CARRIES (1 NO; 4 YES)

Charge number four, engaging in impoliteness and rudeness towards Stephanie Wilcox when interrupting the interview. Blankenship was attempting to conduct and acting disrespectfully towards Wilcox when you were asked to leave. This behavior is in violation of Paducah code of ordinance, section two, Dash 313, A, one, oh, this motion is made to find Nathan Torian, Captain Paducah Fire Department, guilty of charge 4.

CHARGE 5 - CARRIES (2 NO; 3 YES)

Charge number five, disgracing the city of Paducah and city of Paducah Fire Department by attempting to engage in inappropriate and unethical ex parte communications with Supreme Court Justice Nickel. This behavior is in violation of Paducah code of ordinance, section 2776, conduct unbecoming. This motion is made to find Nathan Torren, Captain Paducah Fire Department guilty of charge 5.

CHARGE 6 - CARRIES (1 NO; 4 YES)

Charge number six, engaging in improper conduct, which would tend to bring criticism to the Paducah Fire Department by attempting to engage in inappropriate and unethical ex parte communications with Supreme Court Justice nickel leading to justice Nichols, public disclosure of the communications. This behavior is in violation of Paducah code of ordinance, section two, dash, 313, a, 1k, this motion is made to find Nathan Torian, Captain Paducah Fire Department, guilty of charge 6.

CHARGE 7 - CARRIES (1 NO; 4 YES)

Charge number seven, exhibiting insubordination to Deputy Chief Denton by undermining his direct order that you would not attend AMSC meetings unless requested to do so. This behavior is in violation of Paducah code of ordinance, section two, dash, 313, a, 1c, this motion is made to find Nathan Torian, Captain Paducah Fire Department, guilty of charge 7.

CHARGE 8 - FAILS (3 NO; 2 YES)

Charge number eight, acting rudely by interrupting the AMSC meeting while undermining Deputy Chief Dentons order that you would not engage in the meeting without permission. This behavior is in violation of Paducah code of ordinance, section two, dash, 313, A, one, oh. This motion is made to find Nathan Torian, Captain Paducah Fire Department, guilty of charge 8.

CHARGE 9 - CARRIES (1 NO; 4 YES)

Charge nine, engaging in a dispute with Deputy Chief Denton by undermining his direct order to you that you could not attend an AMSC meeting without his request. This behavior is in violation of Paducah code of ordinance, section two, dash, 313, a, 1r, this motion is made to find Nathan Torian, Captain Paducah Fire Department guilty of charge 9.

FINAL SAY: UNANIMOUS

I'm going to make a motion that, based upon the findings that we've all discussed, that Captain Torian's employment with the city be terminated.
