- Initiated nationwide recruitment efforts, resulting in the hire of Deputy City Manager Billy Tyus & Police Chief Dan Donath
- Established the Economic Development department
- Promoted infrastructure improvement & transparency through the creation of BloomingtonStreets.com
- Following the state vote to legalize recreational cannabis, facilitated the crucial discussion of "what's next?" at a local level
- Partnered with the Boys & Girls Club on the Sunnyside Park project
- Through the City Clerk's office, began recodification of the City Code, which is now searchable online



Economic Development: In & Near Downtown

- Entered into a brokerage agreement with Coldwell Banker Commercial Devonshire Realty for the marketing of the City & IWU-owned site at 800 N. Main St.
- Created the Downtown Bloomington Commercial Real Estate Report, a listing of vacant Downtown commercial real estate in retail, office, & industrial sectors, which is updated frequently & posted to the City's website
- Continued to coordinate streetscape improvements Downtown with the addition of 60 self-watering planters, expanded winter holiday decorations, & an updated Downtown Bloomington wayfinding kiosk map
- Celebrated the Downtown Bloomington Farmers' Market's 10th anniversary of accepting LINK cards from the Supplemental Nutrition Assistance Program (SNAP), receiving a grant to match LINK card purchases at the market throughout the year and another grant from Green Top Grocery to provide additional match to LINK card users, increasing total LINK spending with vendors to almost \$11,000
- Participated in 56 events with an average attendance of 700 people during signature events

Community Development

- Adopted the comprehensive update to the Zoning Ordinance, which was last undertaken in 2006
- Adopted a Carbon Monoxide Detector Ordinance to provide local authority for enforcement of the state of Illinois Carbon Monoxide Detector Act
- Created a new Commercial Building Inspector position to better assist our business community and commercial developers
- Received a \$30,000 Certified Local Government Grant from the Illinois Historic Preservation Agency to update the City's Historic Preservation Plan
- Received one of only six Healthy Housing Initiative technical assistance grants in the nation from the National League of Cities to enhance our aging housing stock
- Received a \$100,000 Home Accessibility Program Grant from the Illinois Housing Development Authority to assist the elderly and disabled with accessibility improvements to their homes
- Provided \$58,000 through the Harriet Fuller Rust Grant, resulting in over \$120,000 of investment in the Downtown

In 2019, the City issued:

- 7,534 construction permits
- 2,255 building permits

Total construction value for the year was \$84,398,357



Public Works

- Completed sewer separation, drainage improvements, resurfacing, & sidewalk improvements on Forrest Street from Morris Ave. to Hinshaw Ave.
- Completed improvements on Front St. from East St. to Madison St.
- Began using Routeware route optimization software on 13 automated refuse trucks, enabling management, crews, & office staff to view & monitor routes & photos of solid waste pickups to improve efficiency & cost-effectiveness
- Completed the Water Infrastructure Master Plan, which creates a 20-year plan for capital improvements & smart water technologies
- Installed two pumps at Fort Jesse Pump Station, obtaining an incentive from Ameren Illinois that covered \$56,396 of the \$61,300 total cost
- Received a grant from the Illinois Environmental Protection Agency to update the City's Watershed Master Plans

Public Safety

Fire

- Responded to 11,402 emergency calls for the year, an increase of almost 700 over the previous year & a record for the department
- Began working on an accreditation document describing our community & on the second phase to identify community risks
- Earned an ISO Public Protection Classification Number 2 for another evaluation period
- Developed specifications & purchased a new 100 foot aerial fire apparatus to be stationed at Headquarters, needed for protection of Downtown & the number of high-rise buildings in that district
- Contracted with SiteMed & now have completed the first annual wellness physicals on over 90% of Bloomington firefighters

Police

- Continued to keep our streets safe from those driving under the influence of drugs and/or alcohol, making 349 DUI arrests, an all-time record surpassing 300 in 2016
- Became ILEAP accredited, a program in Illinois that verifies the Police department has policies, procedures, & daily routines that are in full compliance with the professional standards of modern law enforcement
- Continued to be successful in solving major crimes, including Bloomington's single 2019 homicide, which was solved with the arrest of 3 individuals
- Solved a significant crime series of several armed robberies of primarily check cashing institutions with the arrest of one individual
- Started the process of increasing the public safety camera program, which, though historically small, has been very helpful in solving serious crimes

Quality of Life & More

Parks, Recreation & Cultural Arts

- Completed & presented to City Council the Parks Comprehensive Master Plan
- Finished construction of the Miller Park Zoo concession stand & parking lot
- Renamed the ice center the "Bloomington Ice Center"
 unveiled the memorial "Joe Olson Ice Rink"
- Completed the Rollingbrook Park/Harmony Park inclusive playground project & expanded pickleball courts

Library

- Implemented a new, more user-friendly checkout system & catalog, which involved launching online, paperless registration for new cardholders & waiving all fines that existed on migration day to remove barriers for people that stopped coming to the Library because of accumulated late fines
- Negotiated a bargaining unit contract in a record-breaking 3-half day sessions & 1 full day session
- Worked diligently with City staff to test, train staff on,
 implement the new Kronos timekeeping software
- Increased vocabulary, improved focus, & inspired more active imaginations by encouraging reading during the annual Summer Reading Program; 3,339 children, 572 teens, & 589 adults completed the program
- Partnered with District 87 during Summer Reading to offer a second year of summer lunches, serving 2,522 lunches over 10 weeks
