(DOB: 10/03/14), recklessly permitting C.R. to be placed in a situation where the person or health of the child is endangered, in violation of A.R.S. §§13-3623(A)(2) and (F), 13-701, 13-702, 13-801, a Class 3 Felony.


**COUNT SIX

(DOB: 11/19/11), recklessly permitting the child to be placed in a situation where the person or health of the child is endangered, in violation of A.R.S. §§13-3623(A)(2) and (F), 13-701, 13-702, 13-801, a Class 3 Felony
