(2) To vote for a candidate whose name is printed on this ballot fill in the oval O above or next to the name of the candidate, like •

(3) To vote for a person whose name is not printed on this ballot write or stamp his or her name in the space labeled "Write-in" that appears under the candidates names for such office.

(4) To vote yes or no on a proposal, if any, that appears on the reverse side, fill in the oval O that corresponds to your vote.

(5) Any other mark or writing, or any erasure made on this ballot outside the voting oval or blank spaces provided for voting will void this entire ballot.

(6) Do not overvote. If you select a greater number of candidates than there are vacancies to be filled, your ballot will be void for that public office, party position or

proposal.
