PLEASE TAKE NOTICE that, on July 24, 2025, Atlantic City Electric Company ("ACE" or "Company") filed a petition with the New Jersey Board of Public Utilities ("Board" or "BPU") to report on, reconcile, update, and approve certain proposed changes to the Company's Regional Greenhouse Gas Initiative ("RGGI") Recovery Charge Tariff for its Solar Renewable Energy Certificate ("SREC I" and "SREC II") Financing Programs, its Transition Renewable Energy Certificate ("TREC") Program, its Successor Solar Incentive ("SuSI") Program, its Energy Efficiency ("EE") Programs, its Community Solar Energy Pilot ("CSEP") Program and its Time of Use ("TOU") Pilot Program ("Petition"). Pursuant to the Board's Order dated May 21, 2025 in BPU Docket No. ER24070534, the Company was autho rized to terminate its SREC I Program and transfer the SREC I Program's remaining account balance to its SREC II Program's account balance. The SREC I and II Programs are programs where ACE purchases SRECs from solar projects and sells the SRECs in an auction with other New Jersey electric distribution companies ("EDCs"). The TREC Program is a statewide program established by the Board to provide incentives to solar developers in the form of TRECs. Under the TREC Program, ACE and the other New Jersey EDCs are required to acquire TRECs through a joint program administrator. The SuSI Program is a statewide program established by the Board to provide incentives to solar developers in the form of SREC IIs. Under the SuSI Program ACE and other New Jersey EDCs are required to acquire SREC IIs through a joint program administrator. The EE Programs, comprised of EE Triennium 1 ("T1") and EE Triennium 2 ("T2"), are statewide programs established by the Board pursuant to which the Company administers conservation programs, materials, and education to its customers. The CSEP Program is a statewide program designed to facilitate access to solar energy on a community-wide basis for customers who are otherwise unable individually to participate in solar development programs or projects. The TOU Program was approved by a Board Order dated October 30, 2024 in BPU Docket No. QO23120871 as a mechanism that allows the Company to reduce its system demand during periods of peak use by customers. As set forth in the Petition, the Company is reporting the SREC I balance amount, including accrued interest, that was transferred to its SREC II account balance. Also, as proposed in the Petition, the Company seeks to maintain the tariff charge for the SREC II Program at its current rate of \$0.000000 per kWh; decrease the charge for its TREC Program from the current per kWh charge of \$0.002325 to \$0.002146, including Sales and Use Tax ("SUT"); increase the charge for its SuSI Program from the current per kWh charge of \$0.001155 to \$0.002447, including SUT; increase the per kWh charge for the EE T1 program from the current charge of \$0.002167 to \$0.002244, including SUT; increase the per kWh charge for its EE T2 program from the current charge of \$0.002167 to \$0.002284, including SUT; increase the charge for its EE T2 program from \$0.001431 to \$0.004156 per kWh, including SUT; increase the charge for the CSEP program from the current per kWh charge of \$0.00043 to \$0.000112, including SUT, for the period November 1, 2025 through October 31, 2026; and modify and set the rates for its TOU Program and establish the Summer peak and off-peak rates at charges of \$0.11567 and \$0.056401 per kWh, programs and the Wilster peak and off-peak rates at charges of \$0.113004 and \$0.04571 are kWh.

Pursuant to the Board's authorization as part of it May 21, 2025 Order in BPU Docket No. ER24070534, terminating the SREC I Program, the Company has transferred \$428,027, inclusive of accrued interest, from its SREC I account balance to its SREC II account balance. The SREC II component of the RGGI tariff is based upon actual costs and revenues through May 31, 2025, and projected data from June 1, 2025 through October 31, 2026. The effect of the change in the SREC II component

for this period results in no change to the current charge of \$0.000000 per kWh for the period November 1, 2025 through October 31, 2026. The TREC component of the RGGI tariff is based upon actual costs and revenues through May 31, 2025, and projected data from June 1, 2025 through October 31, 2026. The effect of the change in the TREC component for

this period results in a revenue requirement of \$16.835 million to be recovered from customers over the period November 1, 2025 through October 31, 2026. This results in a decrease in the TREC charge from the current charge of \$0.002325 to \$0.002146 per kWh. For an average residential customer using 643 kWh per month, this represents a monthly decrease of \$0.12 or 0.07 percent. The SuSI component of the RGGI tariff is based upon actual costs and revenues through May 31, 2025, and projected data from June 1, 2025 through October 31, 2026. The effect of the change in the SuSI component for

this period results in a revenue requirement of \$19.193 million to be recovered from customers over the period November 1, 2025 through October 31, 2026. This results in an increase in the SuSI charge from the current charge of \$0.001155 to \$0.002447 per kWh. For an average residential customer using 643 kWh per month, this represents a monthly increase of \$0.83 or 0.51 percent. The EE T1 component of the RGGI tariff is based upon actual costs and revenues through May 31, 2025, and projected data from June 1, 2025 through June 30, 2026. The effect of the change in the EE T1 program for this

period results in a revenue requirement of \$17.916 million to be recovered from customers over the period November 1, 2025 through October 31, 2026. This results in an increase in the EE T1 charge from the current charge of \$0.002167 to \$0.002284 per kWh. For an average residential customer using 643 kWh per month, this represents a monthly increase of \$0.08 or 0.05 percent. The EE T2 component of the RGGI tariff is based upon actual costs and revenues from January 1, 2025 through May 31, 2025, and projected data from June 1, 2025 through June 30, 2026. The effect of the change in the EE T2 program for this period results in a revenue requirement of \$32.599 million to be recovered from customers

over the period November 1, 2025 through October 31, 2026. This results in an increase in the EE T2 charge from the current charge of \$0.001431 to \$0.004156 per kWh. For an average residential customer using 643 kWh per month, this represents a monthly increase of \$1.75 or 1.07 percent. The CSEP component of the RGGI tariff is based upon actual costs and revenues through May 31, 2025. The effect of the change in the CSEP component for this period results in a revenue requirement of \$0.878 million

to be recovered from customers over the period November 1, 2025 through October 31, 2026. This results in an increase in the CSEP charge from the current charge of \$0.000043 to \$0.000112 per kWh. For an average residential customer using 643 kWh per month, this represents a monthly increase of \$0.05 or 0.03 percent, for the period November 1, 2025 through October 31, 2026. As noted above, the Company is proposing to modify its TOU Program and establish the Summer peak and off-peak rates at charges of \$0.211567 and \$0.056401 per kWh, respectively, including SUT; and the Winter peak and off-peak rates at charges of \$0.192904 and \$0.048271 per kWh, respectively, including SUT. The net effect of all proposed changes to the RGGI tariff components for SREC I, SREC II, TREC, SuSI, EE T1, EE

T2 and CSEP charges is a combined annual increase in revenues of \$87,421,894.
