IN LIEU OF PREROGATIVE WRIT

Atlantic City Democratic Committee c/o Gwendolyn Lewis Chairwoman 1502 Penrose Ave., Atlantic City, N.J. 08401Plaintiff by way of complaint says:

FIRST COUNT

- 1. Plaintiff is a political organization representing the Democratic Party in the City of Atlantic City, N.J., it has 42 members elected every two years with a man and a woman representing each of Atlantic City's 21 precincts and upon information and belief approximately 10,000 Registered Democrats.
- 2. Atlantic City Residents for Good Government Inc. ("ACRGG") is a New Jersey Political Action Committee registered with the New Jersey Election Law Enforcement Commission and is located at 1 Convention Blvd., Suite 2, No. 328, Atlantic City, NJ 08401 also known as "Atlantic

City Residents for Good Government."

- 3. The organizers of ACRGG were Farook Hossain, Bob McDevitt, Cristian Moreno-Rodriguez and Felicia Potts.
- 4. Unnamed Petition Committees 1-2 ("UPCs 1-2") are fictitious names of committees which circulated and or submitted petitions to change the form of government in Atlantic City to a Council Manager form pursuant to N.J.S.A. 40:79-1 et seq., the exact names of the Committees and or sponsors not being on the petitions the true names and addresses are unknown at this time. In addition two forms of petitions were utilized making it unknown whether or not there was more than one committee.
- 5. Defendant Clerk of the City of Atlantic City is Paula Geleti who is joined in her official capacity as the person who certified the Petition, scheduled the Special Election and would conduct the Special Election on the question submitted.
- 6. John Does 1-25 being fictitious names are persons whose true names are currently unknown who should be parties to this action because they were circulators of the Petition, or individual pages, and used illegal, improper and fraudulent means to obtain signatures.
- 7. On December 11, 2019 Atlantic City Residents for Good Government, Unnamed Petition Committees 1-2 and or Bob McDevitt submitted change of government petition(s) to the Clerk of the City of Atlantic City containing approximately 3,033 signatures and about 1,670 pages. It is believed that Atlantic City Residents for Good Government, Inc. left out the "Inc." in some of its paperwork but is the same entity however there may be more than one committee, e.g. Defendant UPCs 1-2 or individuals who actually submitted the petitions. See exhibit "C."
- 8. The stated question and purpose of the petition was:Shall subtitle 5 of the title Municipalities and Counties of the Revised Statutes (N.J.S.A.

- 40:79-1 et seq.), providing for the Municipal Manager Form of Government, with five (5) council members all to be elected at-large for concurrent terms at elections held in May, with the mayor elected from among the council members, and a municipal manager appointed by the municipal council, be adopted by the City of Atlantic City?
- 9. On or about January 8, 2020 the Clerk of Atlantic City rejected the Petition, see exhibit "D."
- 10. On or about January 16, 2020 the Clerk accepted the Petition and scheduled a Special Election to be held on March 31, 2020 in the City of Atlantic City, exhibit "E."
- 11. The City of Atlantic City currently operates under the Faulkner Act as a Mayor Council form of government pursuant to N.J.S.A. 40:69A-1 et seq. with 6 wards, 6 ward council persons, 3 at-large council persons, and 1 Mayor elected at-large.
- 12. Sample petition pages are attached hereto as exhibits "A" and "B." The basic question is similar. However Type "A" petitions are made up of about 6-7 pages and contain space for 50 signatures and a circulator and notary affidavit. Type "B" petitions are one page with a title and with room for 5 signatures and the circulator affidavit with notary. See exhibits "A" and "B" attached hereto redacted.
- 13. Neither the Committee members, any sponsors nor the ACRGG committee is listed on the petition as the sponsor.
- 14. The space for the circulator is empty so that it does not have to be filled in before voters sign the petition meaning that the voters are not informed of the sponsor, committee or circulator before signing which is misleading or concealing.

COUNT ONE - Petition is Legally and Facially Defective

15. Plaintiff repeats each and every allegation of the preceding Count(s) and paragraphs above and incorporates the same into each and every other Count and paragraph herein as if set forth at

length herein.

- 16. The petitition is defective as a matter of law.
- 17. The petition in question was required, as a matter of law to follow some of the prerequisites of N.J.S.A. 40A:69A-186 which sets out requirements for initiatives for Faulkner Act municipalities namely including the circulator on each page of the petition.
- 18. The subject of the Petition requests a change in the form of government to the Council Manager form of government under N.J.S.A. 40:79-1 et seq.
- 19. N.J.S.A. 40:79-1 et seq. expressly sets forth the forms for petition in a recall, i.e. N.J.S.A. 40:84-12 and to abandon the Council Manager form of government, N.J.S.A. 40:85-1 et seq. but, provides no other description for the form of petition to change the existing form of government into a Council Manager form of government.
- 20. The petition requirements for identification of circulators should be read in pari materia with N.J.S.A. 40:79-1 et seq. or with the Faulkner Act N.J.S.A. 40A:69A-186 and other provisions that require identification of the circulators and sponsors on its face as does N.J.S.A. 40:84-12, 40:85-1 or 40A:69A-186.
- 21. In this case no sponsors or committee was actually named or identified on the petition forms and in this case the omission was misleading especially since there were two formats.
- 22. The petitions are required to have the circulator listed and in fact do have space for the circulator.
- 23. The petitions are required to be of uniform type to be legal which they are not since there are Type "A" and Type "B" formats.
- 24. Only one format is acceptable for one committee at a time.
- 25. If more than one entity submitted a set of petitions only one can be accepted.

- 26. Upon information and belief after December 11, 2019 the City Clerk continued to accept additional pages and the circulators or committees continued to obtain additional signatures.
- 27. The petition is defective because it is believed that additional pages were accepted.
- 28. There is no 10 day corrective period under 40:79-1 et seq., the Petition needs to be complete when submitted.
- 29. In some cases the notary certificate was attached to more than one set of petition pages which is a fatal defect for those pages.
- 30. In some cases the true circulators were not registered voters.
- 31. In some cases minors were circulators.
- 32. Circulators were required to be New Jersey registered voters at the time they obtained signatures.
- 33. Petition pages circulated by minors and or non voters are void.
- The Clerk ruled in certain cases that some pages of the Petition were defective because the Notary improperly executed the affidavit, or executed it as the circulator, see letter of January 9, 2020. In addition the Clerk invalidated signatures in other cases because the notary was not in good standing at the time of notarization. The Clerk's acceptances and rejections have not been released to Plaintiff and therefore are subject to challenge or are arbitrary and capricous.
- 35. The City of Atlantic City Clerk's Office has not released a complete copy of the pages submitted by ACRGG, UPCs 1-2 or any other entity which submitted the Petition or pages of the Petition and the Plaintiff is entitled as a matter of law to review the materials in the Clerk's office as well as materials used in the signature gathering effort as regular election materials.
- 36. Many or most circulators were paid to obtain signatures on the basis of being paid by obtaining a minimum number, three (3) signatures, which is improper and or illegal just as if a

campaign worker was paid to obtain mail in ballots and was paid per ballot obtained or to register voters and was paid per voter registered. Red Cloud Strategies, LLC was a consultant and or vendor for ACRGG and is believed to have hired, managed and or paid circulators on the basis of signatures the circulators obtained rather than hourly. See exhibits "F," "G," and "H."

- 36A. Any confidentiality provisions regarding circulators or solicitations on a public petition is void, against public policy, contrary to Campaign Finance Laws and or illegal. ("Ryan" named in exhibit H is believed to be the same Ryan on check 148, exhibit F, and Red Cloud Strategies is on check 148, among others.)
- 37. Petitions where the circulator was paid per signature are void and invalid and or the entire Petition is void because it was improperly obtained.
- 38. The number of other deficiencies, irregularities and illegalities is still under investigation and the examples above are representative not exclusive of the deficiencies which are subject to what continuing investigation and discovery will show. The other deficiencies include crossouts, deletions and other markings invalidating pages of the Petition.
- 39. The City of Atlantic City is also subject to the Municipal Recovery and Stabilization Act, N.J.S.A. 52:27BBBB-1 et seq. at all relevant times.
- 40. Pursuant to the above cited act, the Petition is at best advisory and non binding. Further "dissolving, terminating, transferring, abolishing, or otherwise disposing of any municipal authority, board, commission..." is impossible without approval of the Director of the Local Finance Board, id. section 5(b).
- 41. Pursuant to N.J.S.A. 19:37-1 et seq., Elections, Non binding referenda are to be scheduled for the general election which will be held in November, not a special election and the Council Manager Plan conflicts with Election Law and the Municipal Recovery and Stabilization Act and

is therefore legally void or the election must take place in November.

42. In the alternative a declaratory judgment on the effect of conflicting laws is requested pursuant to the Declaratory Judgment Act, N.J.S.A. 2A:16-51 et seq.,

WHEREFORE, Plaintiff demands relief as follows:

- A. The Court Issue an Order setting a suitable time and place for a hearing this complaint;
- B. That at the hearing, the Court determine if the petitions are legally deficient;
- C. That the Court determine whether malconduct, fraud or corruption occurred in obtaining signatures and the legality or illegality of any signatures and the Petition;
- D. That the Court, after the hearing, declare the Petition null and void, be set aside and election cancelled;
- E. That all books, papers, documents and forms relating to the Petition in possession or control of Defendants, the City of Atlantic City and its Clerk, ACRGG, JPCs 1-2, John Does 1-25 or other entities with possession of the same be maintained and produced for discovery and an order be entered permitting Plaintiff discovery, including on Red Cloud Strategies and declare its "Nondisclosure Agreement" null and void, and for inspection and copying of the documents and materials upon an expedited schedule to be determined by the Court including a schedule for production of witnesses and their depositions;
- F. An Order for such other relief as the Court deems reasonable and just.

SECOND COUNT - Fraud

- 43. Plaintiff repeats each and every paragraph and allegation of the First Count above and incorporates the same as if set forth at length herein into each and every other paragraph and Count of the Complaint.
- 44. ACRGG, UPCs 1-2 their committee members and the circulators, and John Does 1-25 are

liable for FRAUD in that the entire petition gathering process was so replete with errors, intentional misconduct, concealment, misrepresentations and other malconduct that the entire Petition is void.

- 45. Specifically ACRGG, UPCs 1-2 their committee members and the circulators, and John Does 1-25 and defendants misrepresented the contents of the petition by concealing and omitting their names as sponsors or their roles in obtaining signatures. See exhibit "I" badges worn by circulators identify Roselle and Linden Democratic Committees not ACRGG, UPCs or Red Cloud Strategies, LLC the employers.
- 46. In certain cases the Notary signed as the circulator which was fraud.
- 47. In certain cases the actual circulators were not persons who signed the Petition or represented themselves as the circulators.
- 48. In certain cases the circulators lied or misrepresented their identities.
- 49. In certain cases to induce voters to sign the contents of the petition was misrepresented.
- 50. In certain cases ACRGG, UPCs 1-2 their committee members knowingly used minors and ineligible persons to circulate the petition.
- 51. ACRGG, UPCs 1-2 and or their committee members concealed the true identities of the actual circulators fraudulently.
- 52. In certain cases the signatures were forged or were not the persons whose names and signature was given, in one case the person has been in living in the State of Florida for years and has not returned to Atlantic City and could not have signed the Petition.
- 53. In at least one case the address given for the circulator does not exist and it was known to be given fraudulently.
- 54. Some petitions were circulated correctly but then additional signatures were fraudulently

appended to the correct signature pages or other persons than the circulator who was correctly listed obtained additional signatures.

- 55. Signatories have been shown photos of circulators listed on the Petition and reported to the Plaintiff's investigator that the correct circulator was not the same person listed in writing.
- 56. It is believed that certain petition pages were left unattended for voters to sign which the circulators then fraudulently or falsely represented they personally witnessed.
- 57. The use of a "Nondisclosure Agreement" in gathering signatures is indicative of Fraud and illegal methods, is illegal and void ab initio.
- 58. The misstatements, concealment, errors and omisions by ACRGG, its committee members, the circulators and defendants were material, knowing and intentional.
- 59. As a result of the misstatements, concealment, errors and omissions by ACRGG, UPCs 1-2 their committee members and the circulators, and John Does 1-25 and or other defendants the signers were induced to sign petitions they would not have otherwise signed.
- 60. There was a pattern of fraud so rampant as to cause doubt in whole petition and process and among other things:
 - (a) illegal or improper signatures were collected;
 - (b) signatures which should have been rejected were accepted some not being eligible voters;
 - (c) signatures were not of the persons listed because they were either forged or the true persons were not the signers who were absent from the State;
 - (d) some affidavits were false;
 - (e) names and addresses given for signatories were false, in that those addresses do not exist or the persons did not sign the petitions.

- As a result of these fraudulent and improper activities, errors, mistakes and problems which a continuing investigation will disclose, the basic safeguards of the petition process were denied and the Petition was procured fraudulently.
- 62. The errors, mistakes and irregularities set forth above are representative of the fraud and errors in the Petition and are not exclusive since Petitioner has not completed its investigation and Plaintiff hereby reserves the right to supplement, amend and plead additional claims as they arise.
- 63. As a result fraudulent signatures were obtained and wrongly approved and a Special Election has been fraudulently called.

WHEREFORE, Plaintiff demands relief as follows:

- A. The Court Issue an Order setting a suitable time and place for a hearing this complaint;
- B. That at the hearing, the Court determine the Petition is legally deficient;
- C. That the Court determine whether malconduct, fraud or corruption occurred in obtaining signatures and the legality or illegality of signatures;
- D. That the Court, after the hearing, declare the Petition be set aside and election cancelled;
- E. That all books, papers, documents and forms relating to the Petition in possession or control of Defendants, the City of Atlantic City and its Clerk, ACRGG, JPCs 1-2, John Does 1-25 or other entities with possession of the same be maintained and produced for discovery and an order be entered permitting Plaintiff discovery, including on Red Cloud Strategies and declare its "Nondisclosure Agreement" null and void, and for inspection and copying of the documents and materials upon an expedited schedule to be determined by the Court including a schedule for production of witnesses and their depositions;
- F. An Order for such other relief as the Court deems reasonable and just.

THIRD COUNT - Civil Rights

- Plaintiff repeats each and every paragraph and allegation of the First Count above and incorporates the same as if set forth at length herein into each and every other paragraph and Count of the Complaint.
- 65. The form of government, Council Manager, N.J.S.A. 40:79-1 et seq. is unconstitutional as it would be implemented in the City of Atlantic City.
- 67. The City of Atlantic City currently contains 6 wards with council members elected from each ward. In addition the Mayor and 3 council members are elected at large.
- 68. Under the plan of the petition all Council Members would be elected on an at large, or city wide basis.
- 69. Atlantic City is home to a large number of citizens from diverse racial, social and ethnic groups and in fact no one group constitutes a majority group in the City.
- 70. If all Council Members were elected on an at large basis numerous citizens would lose their voice and representation in government.
- 71. The present City council contains 1 Hispanic Member, 2 South Asians, 2 Caucasians and 4 African Americans.
- 72. The neighborhoods of the City tend to have one or two groups which do form majorities in their neighborhoods but are not of sufficient size that those groups would be able to elect a Council Member on an at large basis and the form of government proposed uniquely disenfranchises numerous groups.
- 73. As an example there is only one Hispanic Council Member although Hispanics represent

30% of the population.¹

- 74. That would instead tend to equate to two council representatives out of nine on a percentage of population basis.
- 75. The South Asian representatives would most likely not be able to be elected due to language barriers and other circumstances on a City Wide Basis. Jimmy Cheung who previously represented the 5th ward was the first Council Member of Chinese ethnic descent would have been unable on an at large basis most likely to be elected.
- 76. At large districts under the Federal Voting Rights Act of 1965 (52 U.S.C. § 10101 et seq.) are inherently suspect and discriminatory especially when going from a precinct district to an at large district.
- 77. Enactment of the petition and institution of 1 at-large city-wide voting district would be contrary to the Civil Rights of the people of Atlantic City and contrary to 42 U.S.C. 1983 and or the New Jersey Law Against Discrimination N.J.S.A. 10:6-1 et seq. which this Court has jurisdiction to enforce.
- 78. In the alternative the question presents a re-districting plan which would do away with all wards. Given that the U.S. Census will take place this year, 2020, and new districts will be drawn

for New Jersey election districts based on the results, the Court does have jurisdiction to rule on whether a single at large district is permissible.

WHEREFORE, Plaintiff demands relief as follows:

- A. The Court Issue an Order setting a suitable time and place for a hearing this complaint;
- B. That at the hearing, the Court determine if the petitions are legally deficient;
- C. That the Court determine that the Petition is a violation of the Civil Rights of the people of the City of Atlantic City, illegal and Unconstitutional;
- D. An Order for such other relief as the Court deems reasonable and just including costs and fees.



Dear Mr. McDevitt & Petitioners:

Please be advised that as City Clerk of the City of Atlantic City, I am required to review, for sufficiency, petitions which were submitted in support of a change of government under N.J.S.A. 40:79-1, et seq. the Municipal Manager Act of 1923 on December 11 and December 19, 2019. After a thorough and careful review of the submitted petitions by my office and legal counsel, it is my determination that the number of signatures required to satisfy the statutory requirement has not been met for the reasons set forth below:

- 1. All petitions which were notarized by Jayesh K. Sodha were deemed to be invalid due to information received by the State of New Jersey, Department of Treasury that Mr. Sodha is not a notary in good standing properly registered in the State of New Jersey.
- 2. A number of petitions notarized by Rhashonna C. Cosby were improperly executed such that the circulators' names were either not provided or the attestation reflected the notary name and not that of the circulator. Those which were improperly attested were deemed invalid.
- 3. Individuals on petitions who were unregistered as voters or whose information was not legible were eliminated.

The number of valid signatures required to advance the petition is 935. Petitioners have submitted 699 valid signatures. Because the threshold number of signatures has not been met, the petition cannot advance.



I certify that a proper inspection of the submitted Petitions has been performed and the results have been set forth above.







Dear Judge Mendez:

Please accept this letter in lieu of a more formal brief in the above matter on behalf of the Plaintiff Atlantic City Democratic Committee. This matter is being brought as an Order to Show Cause on a Prerogative Writ to restrain the election for a change of government initiated by Petition submitted to the Atlantic City Clerk on or about December 11, 2019.

Plaintiff argues that the Petition is defective, was fraudulently obtained and is unconstitutional among other things and requests entry of a restraining order staying the election until the matter can be heard.

Statement of Facts and Procedural History

The City of Atlantic City operates under a Faulkner Act Mayor Council form of government pursuant to N.J.S.A. 40:69A-1 et seq. This form of government includes a Mayor and 3 council members elected at large and 6 council members elected from each of the City's 6 wards.

The City of Atlantic City is also now subject to the Municipal Recovery and Stabilization Act, N.J.S.A. 52:27BBBB-1 et seq. and was at all relevant times.

On or about December 11, 2019 a Petition pursuant to N.J.S.A. 40:79-1 was filed to change the form of government to a Council Manager type of government with 5 at large council members who would select a mayor from among themselves after election and hire a City

Manager to run the City.. The signatures appear to have been gathered from July to December 2019 and some may have been turned in after December 11th 2019.

On January 9, 2020 the City Clerk rejected the Petition as deficient with 699 signatures allowed out of over 3000 submitted.

On January 16, 2020 the Clerk then accepted the Petition.

According to one receipt the sponsor of the Petition was Atlantic City Residents for Good Government (without "Inc."), hereafter ACRGG. However to be clear the petition pages do not list any sponsor or committee. Further there are two types of petition pages, Type A with 5 signatures and a certification and Type B with multiple pages, the question on the first page and certification on the last page which allows for up to 50 signatures. Because there are two different forms, no committee names or sponsors on the petition it is actually unknown which entity is the sponsor.

Nevertheless, ACRGG is registered with NJ Election Law Enforcement Commission (ELEC) and filed quarterly reports indicating payments to various individuals and companies which worked on the petitions and gathered signatures as circulators or in other capacities.

Plaintiff ACDC alleges the Petition is invalid because it is legally defective, failed to have proper notarizations, failed to identify the sponsor/committee, failed to submit uniform petitions, has numerous crossouts and deletions and for many other problems identified in the Complaint.

Plaintiff ACDC also alleges the Petition was obtained by fraud in that the circulators actually did not obtain the signatures on the petitions, there are forgeries or false names included, the circulators misrepresented the contents or their connection to the sponsor, they paid circulators for each signature they obtained instead of by the hour or for their work irrespective of success in obtaining signature and other reasons.

Plaintiff finally objects to the at large election which would negatively affect representation of minority groups in Atlantic City as a violation the U.S. Constitution.

In regard to the facts and the complaint, Plaintiff has not been able to fully investigate the Petition because it has not had access to the records in the City of Atlantic City Clerk's Office and does not know the basis for the approval of an additional 236 signatures between January 9th and 16th. However ACDC has been able to obtain information about many of the circulators, their methods of collecting signatures and the signatures themselves and submits that the Petition does not contain validly collected signatures and should be thrown out and the election cancelled.

Legal Argument

Point 1. The Petition is defective.

Unlike regular elections, there is no standard law covering petitions in New Jersey. The Council Manager plan, N.J.S.A. is not even clear about the wording of the question which is set out indirectly in N.J.S.A. 40:80-3 for the clerk to place on the ballot:

"Shall subtitle 5 of the title Municipalities and Counties of the Revised Statutes (§ 40:79-1 et seq.), providing for municipal manager form of government, be adopted in (here insert name of municipality)?"

N.J.S.A. 30:80-1 states:

The legal voters of any municipality may adopt this subtitle at a special election to be held in such municipality, to be called by the municipal clerk upon request or petition in writing of the legal voters of the municipality not less in number than fifteen per centum (15%) of the number of persons who voted at the last preceding general election held for the purpose of electing all of the members of the general assembly as shown by the official canvass.

Basically the Council Manager form was established around 1923 and still calls for paper ballots, N.J.S.A. 40:80-3 "The municipal clerk shall provide double the number of ballots as there were voters registered for the last preceding general election in such municipality, to be printed upon plain, substantial white paper."

In comparison the Faulkner Act, the form of government Atlantic City currently operates under is mostly self contained and provides initiative and referendum for almost any issue, N.J.S.A. 40:69A-185 et seq. This includes the need for a committee and verification of the circulators. However it is admitted that the committee need not be named in all circumstances such as in the event of reversion. Nevertheless the circulator portion is mandatory.

Because the format is silent in the Council Manager form we urge the Court to impose the requirement of the Committee for this petition.

In addition it is clear the petitions are not uniform in style either required under N.J.S.A. 40:69A-186. That might not matter if there was a committee of sponsors identifed but in this case because there are two types of petitions we do not know how they were submitted or if more than one committee submitted two different sets. The situation here focuses on the lack of detail in the statute concerning the format of the petition being further taken advantage of by the unnamed sponsors.

While the Walsh Act, N.J.S.A. 40:74-10 also allows initiative and referenda on a local basis the Council Manager form does not and the citizens of Atlantic City would be losing a valuable right if the Council Manager plan is adopted. Therefore it is mostly silent about the

format of the petitions. Both the Faulkner and Walsh Acts permit corrective amendments but again the Council Manager form is silent on that. While it was determined that a reversion to prior form of government from the Faulkner Act does not require a committee to be named, Pappas v. Malone, 36 N.J. 1 (1961), the situation here is different in that Atlantic City would be leaving the Faulkner Act and furthermore the prior form of government was a Walsh Act Commission form.

Clearly the Council Manager form is outmoded to the present day and has not taken into account standard forms of petitions and therefore this petition should be rejected on that basis alone. As a note, Title 19 is silent on the form of petitions except to state that it applies to public questions, N.J.S.A. 19:1-4. N.J.S.A. 1:5-3 is not much help either because it only provides that the signature areas on petitions need to be double spaced.

However there are other reasons for rejection including the fact that Atlantic City is operating under the Muncipal Recovery and Stabilization Act N.J.S.A. 52:27BBBB-1, and any question is advisory only. Title 19 does cover that eventuality in providing that nonbinding referenda should be submitted to the public at the general election, N.J.S.A. 19:37-1.

The petitions have many other numerous deficiencies as indicated by the City Clerk's original rejection letter, Exhibit D to Complaint, including a number of petitions notarized by one notary were improperly executed in that she stated she was circulator and then notarized her own petition if corrrect. Further, reason 3, individuals on petitions were unregistered and illegible. See also Certification for redacted petitions containing examples of the Rhashonna Cosby issues not filed on eCourts.

Upon information and belief several minors circulated petitions which is grounds for rejecting those signatures. Minors are not of full age nor voters and cannot affirm to the necessary circulator's oaths and affidavits.

See also Certification of Samuel Lashman for redacted petitions containing additional examples of problems found by investigation not being filed on eCourts.

In light of the above reasons Plaintiff urges the Court to reject the Petition or at least stay the election pending a hearing on the evidence produced and allow Plaintiff discovery on the reasons for the Clerk's rejections along with granting the Plaintiff access to the petition materials.

Point 2. The Petition signatures were obtained fraudulently.

Many of the same points above concerning physical deficiencies relate to fraud. The facts that minors were circulators, that the notary improperly certified she was the circulator and similar facts given.

In addition the reasons that the committee was not named in this case is another grounds of fraud. Specifically, the Petition is rife with bad signatures.

The Circulators were often not the persons signing the affidavits;

One supposed signatory was in Florida not Atlantic City;

The Circulators were paid on a per signature basis;

We have been advised that additional pages were submitted after December 11, 2019 improperly;

Red Cloud Strategies, LLC included a "Nondisclosure Agreement" as part of its management of the circulators. Paying workers to obtain mail in ballots or registrations per person is usually not allowed and neither should paying circulators to obtain signatures per signature be allowed. See Complaint exhibits "F," "G," and "H." The circulators also wore badges identifying them not from ACRGG but from Roselle or Linden Democratic Committees, see Exhibit I to Complaint. Again neither of those entities was listed as a in-kind vendor or contributor on the ELEC reports.

N.J.S.A. 19:44A-8 Contributions, expenditures, reports, requirements.

a. (1) Each political committee shall make a full cumulative report, upon a form prescribed by the Election Law Enforcement Commission, of all contributions in the form of moneys, loans, paid personal services, or other things of value made to it and all expenditures made, incurred, or authorized by it in furtherance of the nomination, election, or defeat of any candidate, or in aid of the passage or defeat of any public question,

Intentional failure to report work by the Roselle or Linden Committees, constitutes a violation of campaign finance law in a regular election sufficient to invalidate the entire petition not just one or two pages of signatures, see N.J.S.A. 19:29-1 et seq.

The numerous other situations discovered here are more than sufficient grounds to cause rejection of the Petition and under the current circumstances a stay is the only logical course of action.

Point 3. At large districts have been held to be discriminatory.

Again the form of government proposed is almost an antique. It calls for at-large voting in the entire City of Atlantic City which now has 6 district council members and 3 at-large members giving almost every group representation.

The New Jersey Law Against Discrimination, N.J.S.A. 10:6-1 et seq. preserves individuals rights to representation and vote. See Tumpson v. Farina, 218 N.J. 450, 473-480 (2014) addressing the New Jersey Civil Rights Act in context of a citizen's referendum in Hoboken.

At-large district voting schemes have been routinely disallowed under the Voting Rights Act 52 U.S.C. 10101 (formerly 42 U.S.C. 1973) because they disenfranchise numerous groups,

see e.g. Maldef v. City of Pasadena (Texas); Reynolds v. Sims, 377 U.S. 533 (1964) re voting dilution; United States v. Euclid City School District Board of Education (N.D. Ohio 2008); United States v. The School Board of Osceola County (M.D. Fla. 2008); United States v. Village of Port Chester (S.D.N.Y. 2006) [full citations unavailable at this time].

The scheme here is even more suspect in that it was promulgated by private interests. The present City council contains 1 Hispanic Member, 2 South Asians, 2 Caucasians and 4 African Americans. As of the 2010 United States Census, the racial makeup of the city was about 27% White; 38% Black or African American; 16% Asian; 14% from other races, and 5% from two or more races. Hispanic or Latino of any race were 30%.

Based on the at large plan it is unlikely that several council members would be viable, see certifications attached.

Point 4. Plaintiff is entitled to entry of a preliminary injunction.

The standards for granting a preliminary injunction were set forth in <u>Crowe v. DeGoia</u>, 90 <u>N.J.</u> 126, 132-133 (1982). The requirements are (1) showing of irreparable harm; (2) showing that legal right is not unsettled; (3) showing that material facts are not controverted; and (4) testing the relative hardship of the parties, <u>id</u>.

Allowing this Petition to go forward at this time is simply wrong. Even a few month delay would allow proper discovery for a hearing. An analogy is the situation of Mail in votes. Challengers are not permitted to inspect the materials until after the Board of Elections counts and processes them.

The facts shown on the few exhibits and this brief demonstrate the rights of the citizens are about to be violated by conducting an election in these circumstances. Moreover an extension would actually allow both sides more time to campaign while the State of New Jersey does not even have to accept the result making an election a possible exercise in futility.

The purpose of a preliminary injunction is to maintain the parties in substantially the same condition when it is entered as they were when the litigation began, <u>Crowe</u> at 134, therefore an injunction should be entered now.

Conclusion.

For the reasons given, a temporary injunction should immediately be entered and the matter set down for an expedited hearing and management conference.
