

On Monday 05/24/10 at approximately 21:14 Hrs Ofc. C. Ellis and I responded to K-mart 800 W. Black Horse Pike for a report of a physical altercation with a shoplifter. It should be noted while en-route dispatch advised the accused left the area in a gray Toyota Corolla. A check of the area was negative for that vehicle. Upon my arrival I made contact with Cliff Evans, loss prevention employee for K-mart. He advised he observed a Hispanic female on the surveillance camera remove several items from the shelf and place them in her pockets. The Hispanic female was described as having long dark hair wearing a white T-shirt and dark color jeans, and a rag with pictures of money hanging out her back pocket. After placing the items in her pocket she then attempted to exit the store. At that time Javier Rodriguezs, security guard from US Security, stopped the female at the front door. Cliff Evans arrived at the front door and advised the female to removed the items from her pocket. While speaking with the female a Hispanic male came up behind Javier and shoved him and attempted to stab him with a knife. The Hispanic male is described as being approximately 35 to 40 years of age with black hair and a dark color T- shirt and ace bandages on his right arm. At that time an altercation began and the Hispanic male and female left the area in what was said to be a gray Toyota Corolla.													
The items recovered from the female were sun care value \$2.99, 2 tubes of Bactrin value \$6.79 each, 2 packs of curad tape valued at \$3.79 each, and 2 packs of flex tape valued at \$6.49 each for a total value of \$37.13. Cliff advised he would provide this department with a copy of the surveillance footage that shows the accused. Nothing further.
