## **House GOP whip wounded in shooting**

ALEXANDRIA, Va. — A rifle-wielding attacker opened fire on Republican lawmakers Wednesday as they practiced for a charity baseball game, critically wounding House GOP Whip Steve Scalise of Louisiana and hitting aides and Capitol police as congressmen and others dove for cover. The assailant, who had nursed grievances against President Donald Trump and the GOP, fought a running gun battle with police before he, too, was shot and later died.

## Residents petition for vote on MUA sale

ATLANTIC CITY — Residents and activists crowded City Hall's lobby Wednesday afternoon to illustrate the support they've gathered against the state take-

With signs such as "Water is a human right" and "Our water, our voice," about 20 people walked into the city Clerk's Office to deliver 2,400 signatures — 1,200 were required on a petition aiming to force a vote on the sale of the Municipal Utilities Authority.

"This is a culmination of a year's effort in meeting our goal," said Charles Goodman, a member of the Atlantic City NAACP.

The groups went around the city and knocked on doors to circulate the petitions for the past several months.

Mayor Don Guardian spoke in favor of the petition Wednesday, adding that the cost of

## Uber drivers say N.J. rules didn't end A.C. troubles

ATLANTIC CITY — Despite state regulations allowing them to operate here, local Uber drivers say they are still facing challenges, including threats of tickets from city mercantile inspec-

Uber driver Lance Zeaman, of Linwood, said he's been told by the mercantile office he could still receive citations if he continues to operate in the city without a commercial driver's license.

But new regulations that took effect May 1 should have cleared the way for drivers to operate in the city without fear of being cited for not having a commercial driver's license, he said.

MAYS LANDING – The attorney for the physician husband of slain radio host April Kauffman argued Wednesday for the release of his client one day after he was accused of brandishing a gun at federal, county and local officers executing a search warrant at his medical practice.

Seized medical records will be returned as soon as possible, he says. A2

**But Assistant Prosecutor** Carey Schill said the state was asking Dr. James Kauffman be kept in jail until he's brought to trial on weapons offenses stemming from Tuesday's incident.

Judge Bernard DeLury, after hearing from both sides, called for a hearing Monday to decide whether Kauffman will be held or released on his own recognizance.

Tuesday's search warrant was unrelated to the unsolved May 2012 homicide of April Kauffman, authorities said. She was found dead of multiple gunshot wounds in the bedroom of the couple's Linwood
