Resolution Authorizing Extension of the Property Tax Payment Grace Period During a Federal Government Shutdown

WHEREAS, P.L. 2019, c. 491 permits a municipality to extend the grace period for payment of property taxes during an extended federal government shutdown; and

WHEREAS, the law applies if (1) the shutdown lasts more than twenty-one (21) days and is ongoing when the tax installment is due, or (2) the shutdown ended fewer than fourteen (14) days before the due date; and

WHEREAS, the extended grace period is available only to taxpayers, or their spouse / civil union partner / domestic partner, who are: (a) furloughed federal employees receiving unemployment during the shutdown; (b) unpaid but required-to-work federal employees during the shutdown; or (c) federal contractors whose compensation from a federal agency has been withheld or reduced due to the shutdown and who are receiving unemployment; and

WHEREAS, the statute requires applicants to provide proof of eligibility, including (as applicable) a federal paystub or, for a qualifying contractor, IRS Form 1099 and the most recent filed income tax returns; and

WHEREAS, the Township Committee wishes to authorize the Tax Collector to apply this grace period extension for the upcoming property tax installment;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Egg Harbor, County of Atlantic, State of New Jersey, that the Tax Collector is authorized to extend the grace period for payment of the November 1, 2025 property tax installment to February 1, 2026 for any taxpayer who submits acceptable proof of eligibility under P.L. 2019, c. 491;

BE IT FURTHER RESOLVED that the Township Clerk shall transmit a certified copy of this Resolution to the Division of Local Government Services within three (3) business days of adoption.
