ORDINANCE SUMMARY - ORDINANCE 1056
AN ORDINANCE AMENDING CHAPTER 10, CHAPTER 10,
BUSINESSES, REGARDING BACKGROUND INVESTIGATIONS AND
CANNABIS BUSINESSES

On the 1st day of December, 2025 the Shoreview City Council adopted ordinance 1056 amending chapter 10, article II, licensing, and article IV, cannabis businesses. On the same day, pursuant to Minn. Stat. §412.191, Subd. 4, the Shoreview City Council directed that a summary of ordinance 1056 be published.

Ordinance 1056 adds cannabis registrations to the list of licenses the Sheriff's Office will conduct background investigations on. Furthermore, it removes all references to edible cannabinoid products and sales. This is due to changes in Minnesota Statutes where lower potency hemp edibles have replaced edible cannabinoids. Language is also being amended regarding expiration dates for registrations and storage for approved products. A copy

MASSAGE ESTABLISHMENTS AND SERVICES

On the 1st day of December, 2025 the Shoreview City Council adopted ordinance 1057 amending chapter 10, article VIII, massage establishments and services. On the same day, pursuant to Minn. Stat. §412.191, Subd. 4, the Shoreview City Council directed that a summary of ordinance 1057 be published.

Ordinance 1057 adds language allowing for in-home massage therapy

establishments. Additionally, it updates language to prohibit cannabis products or lower-potency hemp edibles in addition to alcoholic beverages on licensed premises.
