APPROVAL OF THE AGENDA- Reagan motioned, Peterson seconded, Approval of Agenda. Carried 4-0.DISCUSSION/INFORMATION ITEMS -Consideration of Operating and Facilities Referenda -Superintendent Duffrin reviewed the long-range master plans previously seen at Regular Meetings and Study Sessions with the school board regarding the facility's plans and amounts for Phase I and Phase II. Duffrin asked the School Board to agree to proceed with deciding the Operating and Facility amounts. Director Reagan expressed concerns about not having to proceed with deciding the Operating and Facility amounts. Director Reagan expressed concerns about not having enough athletic field upgrades, being heavy on safety and security, and not adding Chautauqua seats. Other members noted problems with how to word the ballot questions so they do not fail, the looming tax impact, and whether upgrades of Phase II should be included in Phase I. Suggestions for ballot language were to make questions contingent on the initial question. Concerns also included partnerships, where Duffrin explained that partnerships and fundraising would be done in Phase II, with cities and private donors to help offset the amount to the taxpayers. Tim Erickson, Director of Business Services, then presented the School Board with General Fund Budget Projections. Erickson reviewed the or business Services, then presented the School Board with General Fund Budget Projections. Erickson reviewed the Average Daily Membership (ADM), which has held level through 2026; aid and Levy, under current law, will increase the basic education formula to 2.74% in 2025-2026 and a 2% increase for 2026 through 2028, dependent on the Consumer Price Index. Referendum revenue is about a \$965,000 increase, including the approved use of the fund balance. Erickson also discussed the new state-paid leave payroll charge and the charge of .44% annually. Erickson reminded the board that he is showing projected assumptions and amounts could change based on current legislation but will keep the board up to date. Erickson then displayed a table implicating the shortfalls if the referendum failed and the differences in a referendum being passed at the amount being either \$2M or \$1.75. The projected shortfall in 2026-2027 was at \$1.9M; a projected \$2M potential operating referendum would have a surplus of \$60,021, and at \$1.75M would be a slight deficit of \$189,879. In 2027-2028, a deficit would be around \$524,000 at 2M and \$774,000 at the \$1,75M referendum. Erickson then displayed a table with the tax impact on homes based on the market value of a home. With this information, the School Board felt comfortable asking stakeholders for the \$2M in the operating budget. Duffrin then proposed that the School Board decide on the dollar amount for Safety and Securities Facilities referenda. The school board felt comfortable with the referenda to be under 30M. Ultimately, the School Board could not decide on the dollar amount to ask the taxpayers. The School Board requested an evaluation of cost of each item and the number of individuals impacted, in order to to re-evaluate where the dollars were being spent to include more athletics and gain a further understanding of what safety and security upgrades would be added.
