**SUMMARY ORDINANCE NO. 986** 

AN ORDINANCE AMENDING TITLE XI. CHAPTER 118 OF THE MOUNDS VIEW MUNICIPAL CODE

RELATING TO CIGARETTES AND TOBACCO PRODUCTS

On January 24, 2022, the Mounds View City Council adopted Ordinance No. 986, "An Ordinance Amending Title XI, Chapter 118 of the Mounds View Municipal Code Relating to Cigarettes and Tobacco Products," which amends the existing municipal code pertaining to cigarettes and tobacco products regulations. The ordinance clarifies certain prohibited cigarette and tobacco product sales, primarily that such sales must take place on the licensed premises of retail establishments and not by means of delivery. The ordinance also amends the penalties for tobacco-related violations to ensure consistency with state law, specifically Minnesota Statutes, section 461.12. The business licenses affected by the ordinance include current and future tobacco license holders.
