## CITY OF HUGO PUBLIC HEARING GOODVIEW AVENUE IMPROVEMENTS

TO WHOM IT MAY CONCERN:
Notice is hereby given that the City Council of Hugo will meet at the Hugo
City Hall located at 14669 Fitzgerald Avenue North, Hugo, MN, at 7:00 p.m. on Monday, February 3, 2020, to consider the improvements on Goodview Avenue North from the southern city border to Egg Lake Road/137th Street/County Road 8. The improvements include bituminous pavement reclamation, minor subgrade corrections, and minor drainage improvements, with grading and culvert replacement as necessary to address isolated drainage issues for approximately 1.75 miles of rural street section improvements. The project may also include the extension of sanitary sewer and watermain from 130th Street, east to Goodview Avenue and north along Goodview Avenue approximately 600 ft. Improvements made would be pursuant to Minn. Stat. §§ 429.011 to 429.111. The area proposed to be assessed for such improvements are the properties abutting the proposed improvements or have a shared driveway with Goodview Avenue as their only access. The estimated cost of the improvement is \$2,258,800. A reasonable estimate of the impact of the assessment will be available at the hearing.
