All bidders for contract amounts of \$100,000 or more shall require contractors, sub-contractors, and vendors which have 40 or more full-time employees to submit a copy of their affirmative action certification for the current period after their bid, before construction.

Meetings take place at the District Center in Shoreview (4570 Victoria Street N).

Construction update

Representatives from Kraus Anderson (KA) and Wold provided an update on construction progress and timelines. District staff and personnel from KA shared insights about how the process is working and the progress that has been made to date.

Summer operations projects

Executive director of business services Brady Hoffman shared an update on various maintenance and renovation projects that would be taking place in District facilities over the summer. Projects include partial roof replacements at two sites, painting, updating casework, and flooring replacement in various buildings. All projects are part of the District's 10-year long-term facilities maintenance plan.

Quarterly budget amendments and report

Brady Hoffman, executive director of business services, provided revenue and expenditure reports for all funds for the second quarter ending December 31, 2020. The District continues to closely monitor the budget due to the unpredictability of the COVID-19 pandemic. The District has received one-time federal Coronavirus Relief Funds to help address the unanticipated costs of the COVID-19 pandemic. Each quarterly budget update provides an opportunity to review budget variances and make amendments when information becomes available. The Board approved one budget amendment for this reporting period as presented at the meeting.

Enrollment update

Executive director of business services Brady Hoffman provided the Board with an update of the K-12 enrollment for first semester 2020-21. Enrollment totals at the end of first semester on January 27, 2021, were 11,366 as compared to 11,400 on October 1, 2020. Enrollment will continued to be monitored.

**PUBLIC NOTICE
ARMY ANNOUNCES EXPLANATION OF SIGNIFICANT DIFFERENCES
FOR REMEDIES AT FORMER AMMO PLANT IN ARDEN HILLS**

The Army announces the availability of the Explanations of Significant Differences (ESDs) for Operable Unit 1 (OU1) and Operable Unit 2 (OU2) at the former Twin City Army Ammunition Plant (TCAAP) in Arden Hills, Minnesota. The ESDs for OU1 and OU2 were issued to document the significant differences between the remedy selected in the OU1 Record of Decision (ROD) dated September 30, 1993, which was amended in 2006, and the OU2 ROD dated October 1997, which was amended in 2007, 2009, 2012, and 2014. The permanent granular activated carbon Water Treatment Facility in New Brighton (OU1) and the TCAAP groundwater recovery system (TGRS at OU2), that were the primary treatment components of the original remedies, were not capable of removing an emerging chemical of concern (1,4-dioxane) to levels protective of public health. Therefore, the Army added a supplemental process (advanced oxidation) to each system to treat 1,4-dioxane. The U.S. Army is the lead agency and conducts the remediation for OU1 and OU2 at the New Brighton/ Arden Hills Superfund Site under the Federal Facility Agreement (FFA) signed in 1987 by the Army, USEPA, and Minnesota Pollution Control Agency (MPCA). Under Section 117(c) of the Comprehensive Environmental Response, Compensation and Liability Act of 1980 (CERCLA), as amended by the Superfund Amendment and Reauthorization Act of 1986 (SARA), the lead agency is required to publish an ESD when significant, but not fundamental changes are proposed to the previously selected site remedy. Sections 300.435 (c)(2)(i) and 300.825(a)(2) of the National Contingency Plan (NCP), 40 C.F.R. Part 300, set forth the criteria for issuing an ESD. Both OU1 and OU2 are currently in the Remedial Action Phase of the CERCLA cleanup process. The ESDs are available in the Administrative Record at <https://tcaaprab.org>
