Section 1. Findings. Pursuant to Minnesota Law, the City of Hugo City Code, and upon a review of a study conducted by City staff, a fee schedule for City services and licensing is hereby adopted for the following:

AN ORDINANCE WITHIN THE CITY OF HUGO, MINNESOTA AMENDING CHAPTER 90 (ZONING ORDINANCE) OF THE CITY CODE TO CLASSIFY CERTAIN LANDS LOCATED NORTH OF 159TH STREET NORTH AND EAST OF FOREST BOULEVARD NORTH

THE CITY OF HUGO ORDAINS:

Section 1. Amendment of the City Code. Chapter 90 of the City Code of the City of Hugo, Minnesota, is hereby amended by changing the classification on the City of Hugo Zoning Map to General Business (C-2) with respect to the property legally described as follows:

OUTLOT B, The Shores of Oneka Lake, Washington County, Minnesota.

Section 2. Effective Date. This amendment shall take effect upon its passage.
