ZONING ORDINANCE REGULATING ACCESSORY STRUCTURES

On December 2, 2025, the City of Pine Springs adopted an ordinance amending the City of Pine Springs zoning ordinance regulating fences and accessory structures and facilities by amending the term building to structures and facilities, removing the definition for fence, removing inapplicable regulations, clarifying existing regulations, adding language from model regulations of fences and accessory structures and facilities, and revising the term special use permit to interim use permit.
