209.020 Noise.

(C) Hourly Restriction of Certain Operations.

(3) Refuse Hauling. No person shall collect or remove garbage or refuse in any residential zoning district except between the hours of 6:00 a.m. 7:00 a.m. and 6:00 p.m. 7:00 p.m. on Monday through Saturday.
