 4. SERVICE: You may lose your case if you do not send a written response to the Plaintiff. If you do not serve a written *Answer* within 21
- days, you may lose this case by default. You will not get to tell your side of the story. If you choose not to respond, the Plaintiff may be awarded everything they asked for in their *Complaint*. If you agree with the claims stated in the *Complaint*, you don't need to respond. A default judgment can than be entered against you for what the Plaintiff asked for in the Complaint.
